RESOLUTION # _____-2017

A RESOLUTION OF THE THREE FORKS CITY COUNCIL ADOPTING & LEVYING THE ASSESSMENTS FOR THE 2017-2018 STREET LIGHT DISTRICT NO. 1

WHEREAS, pursuant to §7-12-2201 and 7-12-4333, MCA, the Three Forks City Council may levy and assess on all of the lots, parcels and tracts within the boundaries of Street Light District No. 1 for the entire cost of the annual expense of electricity and maintenance of street lights within Street Light District No. 1. The estimated total annual cost is \$35,306.22. The total amount assessed for Fiscal Year 2017-2018 is \$36,000.00; and

WHEREAS, pursuant to §7-12-4425, MCA the Council should levy and assess the amount for each district by the second Monday in August annually. However, it was always believed that the assessment would need to be finalized by this date which is before the annual budget is finalized, therefore the City has not met this requirement. The City recently learned that §7-12-4425, MCA states “estimated” so in future years the City will estimate the assessment via resolution no later than the second Monday in August annually; and

WHEREAS, pursuant to §7-1-4127, MCA the City Clerk published in the Belgrade News a notice of the existence of this Resolution and the list of assessments to be available for inspection at the City Office (206 Main Street) of Three Forks, Montana on August 17, 2017, and in the Bozeman Daily Chronicle on August 20, 2017; and

WHEREAS, the City Council held a public hearing on August 22, 2017 to hear objections to the adoption in the City Council Chambers, 206 Main Street, Three Forks, Montana; and

WHEREAS, _____ objections were presented to the Council.

NOW THEREFORE BE IT RESOLVED by the Three Forks City Council does hereby levy and assess the entire cost of the estimated annual expense upon each lot, or parcel and tract Street Light District No. 1 the cost of \$34,009.32 which bears to the assessable area of the entire district.

Attached hereto and marked Exhibit “A” which is hereby incorporated herein by reference is a list which describes (1) each lot, parcel and tract of land within Street Light District No. 1; (2) the total number of square feet; and (3) the amount levied against each lot, parcel or tract.
