PAYMENT

PAYMENT IS REQUIRED SEVEN DAYS FROM INVOICE

You will receive a tax invoice stating entry fee/s owed and request for prepayment, prior to the running of the Clipex Livestock Competitions. You are able to pay via credit card, EFTPOS or direct debit. Payment methods will be stated on your tax invoice.

BIOSECURITY

Queensland's biosecurity livestock movement requirements are to prevent the spread of pests and diseases, and safeguard your business, our food and markets. Procedures and facilities are in place to ensure livestock can be identified and movements traced, ensure livestock are free of certain pests and diseases including cattle ticks and Johne's Disease, prevent chemical residues in stock and products, ensure animals are well cared for during transportation.

INTERSTATE TRAVEL

A certificate of health to bring livestock into Queensland is no longer needed, instead, owners must ensure that they understand and have met all requirements for moving livestock within Queensland. People introducing livestock into Queensland should seek a written assurance about the health status of the animals to be introduced.

FIELD SERVICES

ACCOMMODATION

Camping accommodation is available for Livestock exhibitors and competitors only. If you require accommodation in the FarmFest Livestock Area you will be required to apply - there are a limited number of camp sites available working under COVID compliance. When completing your Livestock Competition entry form you will be requested to nominate if you require camping accommodation - if yes, you will later receive a link to complete the Accommodation online registration form and submit. Once you receive confirmation, please call in to the Livestock Area office upon arrival at the site to receive your allocated campsite number in the Northern or Southern Camping areas. You will be unable to set-up until you receive your number and camping site map. Please indicate if you have a requirement for a powered or un-powered site, fees apply. Restrictions apply to campfires and barbeques in the camping accommodation area.

CAR PARKS

All vehicles must be removed from the Livestock Area before 8.00am each morning, before commencement of the event at 8:30am. New car parks have been created and marked to provide space for trucks, goose necks, motor vehicles on the outer perimeter of the Livestock Area. All COVID safety and traffic safety signage and instruction from the organisers must be obeyed. We appreciate your co-operation and understanding of the importance to adhere to new vehicle compliance - with no vehicular movement permitted in and around the Livestock Area during public opening times.

LIVESTOCK OFFICE

The Livestock Office is located on the southern side of the Livestock Arena. It is open from Sunday 5 June 2022 to Friday 10 June 2022 from 9am to 5pm daily.

LOADING RAMP

A permanent loading ramp is available upon entry into the Livestock Area on the northern side of the field.

PORTABLE LOADING RAMPS

Portable Loading Ramps are available to unload "unled" cattle onto sites for display. These must be booked with the Livestock Office. Under HSE rules, no Livestock exhibitor can remove the loading ramps without an ACM Rural Events designated staff member. All stock being unloaded on any loading ramps must be of suitable temperament for display.

STALLS

Stalls are available for all Livestock competitors and their animals. Stalls are allocated on receipt of entry. Call into the Livestock Office upon arrival to receive your allocated free stall which includes sawdust. Livestock Competitors are responsible for keeping the stall area allotted in a clean and presentable condition throughout the competitions. The stall is to be cleaned regularly with refuse deposited in the manure pits provided. General purpose rubbish must not be deposited in manure pits. To assist in the transfer of manure to the pits provided, please bring own equipment.

NLIS

All competitors are responsible for supplying a NVD/ Waybill to the FarmFest NLIS contractor. All competitors must provide the FarmFest NLIS contractor the Property Identification Code (PIC) of where the livestock have come from.

NLIS SCANNING

The NLIS contractor will be scanning on 6 June 2022 between 2pm to 5pm only. All livestock exhibited on the site must be

identified with the National Livestock Identification System (NLIS) device prior to leaving place of origin.

LIVESTOCK MOVEMENT

All competitors are reminded when moving stock over the age of 12 months on the site, a nose-ring or nose clip must be fitted to the animal.

PRIZES

Prize money for Livestock competitions to be collected from **1pm on Tuesday 7 June, 2022** from the FarmFest Headquarters upon receipt of a signed prize card from the FarmFest Livestock Office.

Other Livestock prizes can be collected from the FarmFest Livestock Office prior to 4pm Thursday 9 June 2022 upon receipt of a signed prize card from the FarmFest Livestock Office. **Prizes not collected by 4pm Thursday 9 June 2022 will be forfeited.**

SAFETY

ACCIDENTS

- Report all accidents, incidents and hazards to the Livestock Office or if closed - directly to the FarmFest Headquarters on B/19.
- The first aid facilities are on site B/20. If you are in need of first aid please report to the Livestock Office.

COVID SAFE

- **You must take action to protect all Livestock competitors and others at the Livestock Area from the risk of exposure to COVID so far as reasonably practicable.**
- **Wellbeing and health - if unwell please do not attend competition**
- **Physical distancing - Support 1.5m physical distancing and avoid congestion of people in specific areas, where possible**
- **Hygiene and cleaning - Adopt good hand hygiene practices. Use hand sanitiser as located in the Livestock Area, and wash your hands. Clean frequently touched areas and surfaces**
- **Record keeping - ensure you register your attendance at the FarmFest field days daily using the Check In QLD app, QR sign located at the Livestock Office or as provided, once a confirmed Livestock Competition entrant**

CODE OF BEHAVIOUR

- The competitor is responsible for the good conduct of their staff, students, contractors present at the Livestock Area and FarmFest field day site.
- At all times, ACM Rural Events, its event staff and

security reserve the right to request any person on site to leave the event if they feel there is a threat to the safety or smooth conduct of the event.

DOGS

- No dogs. With the exception of guide dogs for the vision impaired, service dogs for medical or disability requirements and working dogs involved in official demonstrations, no dogs are permitted on-site.

ELECTRICAL

- All power leads, electrical appliances and equipment brought onto the site must be tested and tagged in accordance with Australian Standards AS 3760. If no tag is evident, it will be a requirement of the owner to have such equipment tested and tagged by the authorised FarmFest Electrical Contractor at their own expense. To organise, check with the Livestock Office. No double adaptors are permitted to be used on site.

HEALTH AND SAFETY RULES

- Work, Health and Safety (WHS) legislation requires the competitor to work with the organisers, ACM Rural Events, to identify potential hazards and to assess the risks involved to anyone present on the Livestock Area site including workers and visitors.
- Competitors must exercise extreme caution in

SAFETY

- supervision of staff, students, contractors and their agents.
- It is important for competitors to consider their stall neighbours and other competitors to ensure issues such as noise etc do not disrupt others.
- Conduct a safety check of the stall area before and at the end of Competition times.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

- Remember to apply correct Personal Protective Equipment for the job task.

SIGNAGE

- Obey all safety signs and instruction from ACM Rural Events and their staff on-site.

VEHICLES ON SITE

- No keys are permitted to be left in unattended vehicles on-site.
- No vehicular movement is permitted during public event opening times on or around the Livestock Area.

- Following unloading, all motor vehicles, trucks, goose necks must be located in the Livestock Area car park - no vehicles are permitted to be parked in the Livestock Area.

WATER

- Open water troughs and water tanks can pose a serious risk especially with children. In accordance with the Work Health and Safety Act 2011, it is recognised water safety on site is paramount. If you have a requirement to supply your own water for stock, control measures are required to be implemented. The water trough/vessel is to be safety checked daily. Seal water tanks if they contain water so children can't get in. The water trough/vessel is to carry no more than 400 litres with a grate inserted. Ensure warning signage is installed on all equipment — Children to be accompanied by an adult, no climbing.

WEIGHING

Weighing will commence on Monday 6 June 2022 from 1pm to 5pm only. To be eligible to enter the FarmFest Livestock competitions, please ensure your cattle are available to be weighed during this time slot - and be included in the printed competitions catalogue.

TERMS & CONDITIONS

1. The competitor shall comply with all relevant laws affecting its participation on the FarmFest site.

COVID SAFE

2. Livestock competition entrants are responsible for complying and implementing the public health measures issued by health authorities including Queensland Health and the Australian Government Department of Health. It is vital that you adhere to the Event Organisers COVID compliance and safety directions. Stay safe by taking some simple precautions, such as registering your attendance, physical distancing, avoiding crowds, cleaning your hands, coughing into a bent elbow or tissue, keeping enclosed areas well ventilated and staying away if feeling unwell.

PUBLIC LIABILITY INSURANCE

3. All competitors must have their own Public Liability Insurance.
4. Neither ACM or its employees will be responsible for any accident that may be caused through or by any competitor, and it shall be a condition of entry that each competitor shall hold ACM Rural Events or its employees harmless and indemnified against any legal proceedings arising from any such accidents or incidents.

INDEMNITY

5. The competitors shall be responsible for and shall indemnify ACM against, liability for all loss, theft, damage or injury to persons or property arising from the actions of or caused by the competitor, its agents or contractors in connection with the provision of the competition services.

ENTRY FEES

6. No refunds of entry fees given.
7. Competitors under 16 years of age MUST have a supervisor with them at all times.

LIVESTOCK ELIGIBILITY

8. No hormonal growth promotant (HGP) treated animals allowed to compete.
9. All cattle are eligible except those from restricted or quarantined herds.
10. All steers and heifers must be milk tooth and will be mouthed at weighing if required.
11. All steers and heifers must be polled or dehorned.

NLIS

12. All competitors on the site must supply a National Vendor Declaration (NVD)/Waybill to the FarmFest NLIS contractor. The NLIS contractor will be on-site on Monday 6 June, 2022 between 1pm to 5pm. Competitors will be responsible to provide the Property Identification Code (PIC) of where the livestock has come from.

STUD CATTLE CLASS ELIGIBILITY

13. To be eligible for the Stud Classes including Battle of the Bulls and Fantastic Females, only Livestock exhibitors are permitted to enter. The Livestock exhibitor must be registered with a recognised Breed Society or Association. Checks of Breed Society registers will be made if

necessary. All Livestock must arrive on the site between 9am and 5pm on Monday 6 June, 2022. Livestock arriving outside of these hours will be refused entry.

LED STEER & HEIFER CLASS ELIGIBILITY

14. Steers and heifers can only compete in one section – Young Leaders in Agriculture or Open, but not both.
15. Steers and heifers entered in the Young Leaders in Agriculture section, Classes 1-4, must be paraded by a handler 18 years of age or under.
16. All Livestock must arrive on the site between 9am and 5pm on Monday, 6 June, 2022. Livestock arriving after 5pm will be refused entry.
17. All steers and heifers must be weighed. Weighing will commence from 1pm to 5pm on Monday 6 June, 2022. Steers and heifers not weighed during this nominated time will be ineligible to compete.
18. Judging will commence at 9.30am on Tuesday 7 June, 2022.

PRIZE MONEY

19. Prize money for Livestock competitions to be collected from 1pm on Tuesday 7 June, 2022 from the FarmFest Headquarters upon receipt of a signed prize card from the FarmFest Livestock Office.
20. Other Livestock prizes can be collected from the FarmFest Livestock Office prior to 4pm Thursday 9 June 2022 upon receipt of a signed prize card from the FarmFest Livestock Office. Prizes not collected by 4pm Thursday 9 June 2022 will be forfeited.

LIVESTOCK COMPETITION SAFETY

21. All cattle must have a nose ring or nose grip with lead attached when being led.
22. All steers and heifers must be bedded on sawdust due to fire risk (sawdust will be supplied)
23. All steers and heifers must be quiet and controlled by handlers at all times.
24. To comply with the Work Health and Safety Act 2011 each competitor is responsible for the creation and maintenance of a safe environment for their staff, servants, students, agents, contractors and visitors.
25. All power leads, electrical appliances and equipment brought onto the site must be tested and tagged in accordance with Australian Standards AS 3760. If no tag is evident, it will be a requirement of the owner to have such equipment tested and tagged by the authorised FarmFest Electrical Contractor at their own expense. To organise, check with the Livestock office. No double adaptors are permitted to be used on site.
26. No keys are permitted to be left in unattended vehicles on site.
27. No vehicular movement is permitted during public event opening times on or around the Livestock Area.
28. The competitor, its servants, agents, contractors will ensure that all vehicles it brings on the site have current registration and compulsory third party insurance.

29. All traffic management instructions must be adhered to in accordance with vehicle passes issued and/or written/verbal instructions given.
30. The competitor must ensure they wear personal protective clothing including high visibility clothing and enclosed footwear.
31. The competitor, its servants, agents, contractors must obey all safety signs and instruction from the organisers and their staff.

ORGANISERS

32. It is understood the FarmFest site is owned and operated by ACM. The organiser wherever appearing shall include Agricultural Publishers Pty Limited ABN 55 000 560 430.

ANIMAL WELFARE

33. Livestock exhibitors and competitors must comply with the Australian Animal Welfare Guidelines to ensure all livestock are treated in accordance with good animal welfare practices including adequate shelter, feed and water as required, provision of a rest area and limited time on display. Livestock must be in a healthy condition. If vet treatment is required whilst on the site the stock owner is responsible for any costs incurred.

DOGS

34. No Dogs. With the exception of guide dogs for the vision impaired, service dogs for medical or disability requirements and working dogs involved in official demonstrations, no dogs are permitted on-site.

JUDGES DECISION

35. The judges' decision is final and no correspondence will be entered into in relation to their decision.

BIO SECURITY

36. To comply with the Qld Biosecurity Act 2014, all Livestock exhibitors and competitors have a general biosecurity obligation (GBO). This means that everyone is responsible for managing biosecurity risks that are:
under their control and that they know about, or should reasonably be expected to know about.

LIVESTOCK ENTRY REQUIREMENTS FOR QUEENSLAND

37. A certificate of health to bring livestock into Queensland is no longer needed, instead, owners must ensure that they understand and have met all requirements for moving livestock within Queensland.
People introducing livestock into Queensland should seek a written assurance about the health status of the animals to be introduced.

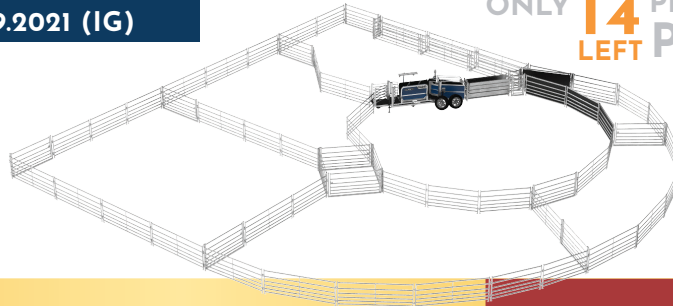

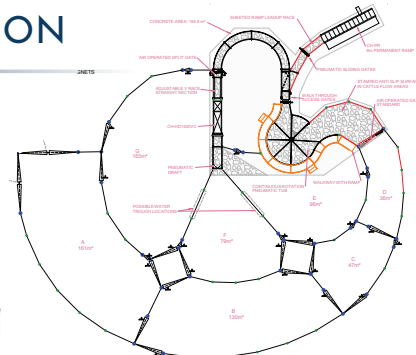
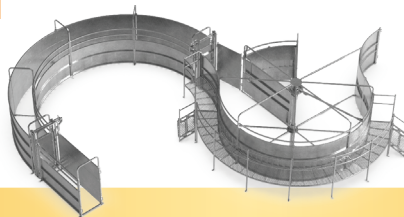
