Persons carrying on an aerial application business either under the authority of an air operator certificate or equivalent authority issued by Transport Canada or under and in compliance with an exemption from that requirement as authorized by applicable legislation and regulation may apply for membership in the Association as an Operator Member. Operator members are not entitled to vote for the election of directors, but otherwise are entitled to attend and to exercise two votes each at meetings of members of the Association.

**Please Ensure All Membership Information is Correct.** If your Membership status has recently changed, contact the CAAA office to update. You may have submitted your Membership as part of the CAAA Partnership Package. If Membership is already completed, please disregard notice.
