I solemnly swear....to be a Superhero?

I am honored and excited to serve as your President for the Greenville County Bar Association in 2017. The Greenville Bar is committed to advancing the collegiality and professionalism of our Bar through numerous events scheduled for the year ahead. These events include social hours, lunches, and signature events such as the annual steak and lobster cookout in July, the barbecue in October, and the Christmas party in December. Additionally, we offer outstanding value at our CLE in February, Law Week activities in May, and numerous opportunities to serve the Bar and community throughout the year. One such service opportunity I would like to announce is a new Pro Bono initiative.



The purpose of the Pro Bono initiative is twofold: to promote justice and to improve mentoring opportunities in our profession. Justice is a universal value. The Bible and other religious texts urge us to seek justice. The United States was founded upon the ideal of establishing justice, as proclaimed by the Preamble to the Constitution. Our Pledge of Allegiance calls for "justice for all". But who is responsible for making justice happen in the real world? As lawyers, we are uniquely positioned to bring about justice for all. More than the average citizen, we have access to the courts. We are able to pursue legal actions in order to advocate for our clients. And I think that with this power comes responsibility for promoting justice.

I often think of Superheroes like Spider-Man or Superman when I think of lawyers. 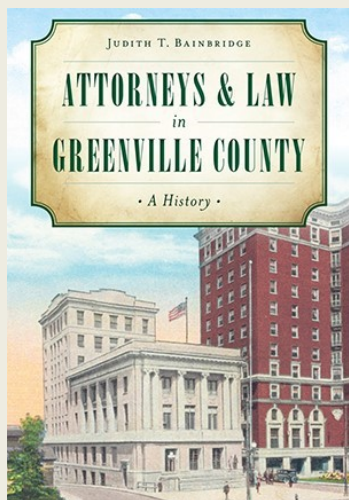
