

The Columbus Weddings Show “Registry Contest” — Official Rules

ENTRY. By entering the contest in the manner described below, all participants (“Entrants”) agree to be bound by these and all posted Official Contest Rules. No purchase or other valuable consideration is required to participate. Void where prohibited by law. To be eligible to win prizes individuals must be 18 years or older; must be a legal resident of the 50 United States or the District of Columbia and legally eligible to marry. One entry per person. Entrants must complete all of the requested information for their entry to be valid. GateHouse Media Ohio Holdings II, Inc. and affiliated companies and/or sponsors, are not responsible for incomplete entries, whether due to equipment malfunction or other difficulties, and are not responsible for lost entries. All entries submitted become the property of GateHouse Media Ohio Holdings II, Inc., and Entrants consent by their participation for GateHouse to provide your contact information to exhibitors and sponsors and for them to contact you, including by email.

PRIZES.
