First off, we are very excited that we have been approved for an Indiana Department of Environmental Management Section 319 Watershed Improvement Grant and a TNC grant to write a Water Quality Management Plan for the Otter Creek Watershed (for details see pg. 5). To jump-start this effort OLC had its first Field Day for Otter Creek Watershed stakeholders in August. Thanks go to the presenters: Adam Grossman (OLC), Josh Brosmer (IDEM), Courtney Natt (ISU). Brendan Kearns (OLC), Dr. John Whitaker (OLC), Jerimiah Lemmons (IDNR); and to Evan Boyer (OLC) for organizing this event! In addition, thanks to our sponsors: Sycamore Trails RC&D; Vigo, Clay, and Parke County SWCDs; The Nature Conservancy; Alcola Foundation; and Baesler's Market. Thanks to all of you we were able to start getting the word out about this much anticipated project to many new stakeholders in the Otter Creek Watershed. We look forward to continuing these partnerships and our other 319 Grant partnerships (see last year's newsletter for a complete list) to improve Otter Creek's water quality.

Next, OLC was also able to get an additional 123 acres of the McDonald Farm in a Conservation Easement. Thanks to Jim McDonald and Hansford Mann for getting this done (see pg. 3)!

Some of my favorite activities were the Spring Wildflower and Fall Foliage Hikes at our properties (see pg. 4). It was so awesome to see families coming to enjoy the great outdoors. I was thrilled to see children running through the woods and prairie, while learning about the environment; isn't that what OLC is all about!! We are also very excited that we have four new Directors. Dr. Susan Berta, ISU Associate Professor, who steps up from the Advisory Board to continue to help us with her mapping skills. #### Mc Donald Farm Conservation Easement



Ouabache Land Conservancy is honored to announce that as of December 14, 2016 a Conservation Easement (CE) consisting of a 122.96 acre parcel of property located in Fayette Township, West Terre Haute, Indiana has been accepted. This Conservation Easement is an addition to the 248 acre property, owned by James McDonald and family, on which OLC currently holds a CE. The property will be given the same consideration that the existing contiguous 248 has in place with woodlands, wetlands, wildlife food plots, and natural habitat all protected. This now is a nice large block of 371 acres of property protected from development. Our great appreciation goes out to the McDonald Family for allowing OLC to hold this CE for future generations!

#### An Exciting Time for the Otter Creek Watershed

The Ouabache Land Conservancy has dedicated much time and effort toward the improvement of water quality in the area it serves. Within the heart of this area is the Otter Creek Watershed. This watershed drains approximately 124 square miles, and covers parts of Clay, Vigo, and Parke counties (map on pg. 6). Almost the entire watershed stream segments are impaired and on the state's 303(d) list. Testing has already begun in this watershed. In 2009, IDEM performed sampling at many sites through the area to gain a baseline. Indiana State University partnered with us to extend that data gathering for an additional year. This extension was made possible through The Nature Conservancy and the Alcoa Foundation.


In 2015 the OLC started writing for what is called a 319-Watershed Improvement Grant totaling almost \$200,000. This grant is strictly a VOLUNTARY program, with no new regulations put upon anyone. It is a chance given to communities to improve water quality at the local level, with programs that make sense for our landowners that they want and will participate in. The 319 grant is a two phase grant to address water quality concerns in the Otter Creek Watershed. Step one is to write a Water Quality Management Plan. This will require the continued dedication from OLC, plus a contracted position that will be the Watershed Coordinator for the grant. This person, under direction of the OLC Board, will be responsible for writing the plan directed by a steering committee. This steering committee is made up of local landowners, stakeholders, and anyone with the knowledge to help direct our efforts. At times through this cycle, the committee will meet monthly in order to steer the grant in the right direction. After our plan is written approximately 2 years after hire and tailored to fit our community and our needs, we will apply for implementation funds to apply these best management practices. This means that local land owners will receive cost share funds to put into practice what is identified in the written plan. Possible best management practices include: buffer strips, cover crops, alternative watering sources, and many more.

The new Coordinator will hit the ground running, and will be setting an informational meeting with the public, as well as sending out media releases letting everyone know the grant is officially starting in the early part of 2017. It is at that point we need the community to come to these meetings, offer opinions and ideas, and guide this plan.

We will be asking very soon for applications to fill our Watershed Coordinator position, and we will also be asking for your help. This grant will only be successful if we all work together to come up with a great plan that works. We as a community need to show our excitement, and our desire for this grant to succeed. We need people to sign up to be on our steering committee so that we are a diverse committee and all needs are met. We expect to call on you early next year to help us with this grant, and help us improve our waters, not only for us, but our downstream neighbors.
