Day camp is a unique and exciting opportunity for girls to have fun, improve skills, make new friends, experience the outdoors, and learn from positive adult role models! To be successful at day camp, it is important to remember the Girl Scout Promise and to live by the Girl Scout Law.

Girl Scout Law

I will do my best to be honest and fair,

I agree to follow all camp rules.

I agree to tell the truth in situations that involve conflict.

friendly and helpful,

I agree to get to know campers (adults and children) by learning their names and understanding that their personalities and values may be different from my own.

I will be sure all campers and PAs feel comfortable, included, and safe.

considerate and caring,

I agree to participate fully in the camp experience by leaving my cell phone and all electronics at home. I understand that if I break this agreement and bring these items, Girl Scouts of Oregon and SW Washington is not responsible for these items.

I agree to be courteous to everyone.

I agree not to pass judgment of others because they are different from me.

I understand that my behavior directly affects the others in my group and I will do my best to be a positive group member.

courageous and strong, and

I agree to let a core staff member know about any behavior I witness that may be hurtful or harmful to myself or others. I agree to use coping skills if I become upset with something.

responsible for what I say and do,

I agree to use appropriate language and behavior. Unsafe rowdiness, fighting, sexual harassment, racist remarks, bullying, threatening, inappropriate gestures, or acts of violence or abuse to myself or others is unacceptable.

I agree not to bring alcohol, tobacco, controlled substances, illegal drugs, firearms or weapons to camp.

I agree to wear appropriate clothing; including closed toe shoes, camp shirts, and shorts that aren't too revealing.

I agree to arrive on time and be sure at least one volunteer from my unit is at the morning staff meeting.

and to

respect myself and others,

If I am having a problem with someone or something, I agree to respectfully talk to that person and/or the volunteer coordinator. I will treat people like I would like to be treated; from campers to PAs to adults. I will speak courteously and respectfully to everyone at camp.

I agree to respect wildlife and not cause harm.

respect authority,

I agree to remain with my unit at all times, unless my unit is with PAs in the meadow, or I have worked with the volunteer coordinator to take a break.

I agree to use the buddy system at all times.

I will support PAs in being role models by modeling appropriate behavior at camp.

use resources wisely, make the world a better place, and

I agree to respect all property- both man-made and natural resources.

I agree to help other campers and staff to keep camp clean and to "leave no trace."

I agree to have an accepting attitude toward others who have values and cultural experiences different from my own.

be a sister to every Girl Scout.

I agree to be open to ideas other than my own and willing to cooperate for common objectives.

I agree to do my best to have fun, try new things, make new friends and enjoy my camp experience in the spirit of Girl Scouting.

I have read the above rules and responsibilities and agree to abide by all of them. If I fail to follow the rules and responsibilities, I understand that I will be reminded once. I understand that my appointment as a leader could be revoked if I cannot support these rules and I would no longer be able to participate at camp. As such, all of my children's camp status could change.
