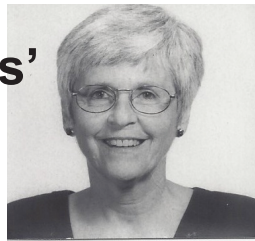

Presidents' Message



Our annual meeting is this month, which means that it is a good time for us to reflect on the progress we've made this past year and the challenges that we face in the coming year. It was an excellent year, and here is why!

- Membership is up! We went from 278 members last year to 365 this year.
- New member orientations were held almost monthly because of our membership growth.
- Our organization is financially healthy...thanks to generous member donations, our condo election fundraisers, and grants.
- Programs—ranging from immigration to Metro to elections that have consequences—led to amazing unit discussions.
- Forums on the election's analysis and redistricting were well attended, and they informed our membership and the public.
- Our publications—including the *VOTER*, *Facts for Voters*, *Voters Guide*, and *What's on the Ballot?*—are top notch.
- Our voter service and registration tables were all over the County, ranging from schools to Starbucks.
- Advocacy was strong on redistricting, elections reform, gun violence prevention, environment, domestic violence, libraries, the County budget, Metro Fund It/Fx It, and much more.
- Candidate forums—both televised and in-person—educated our County's citizens on the candidates running for office.
- Our website, Constant Contact emails, Facebook, and Twitter were in full motion.

Despite these great successes we are facing several challenges. The political environment continues to be divisive. It is more important than ever for the League to continue to strive for civil discourse and to maintain our non-partisanship at all times.

We have just eight months to forge ahead on redistricting reform, one of our highest priorities. We need to continue our

fight against gerrymandering in pursuit of an independent redistricting commission.

While the League's mission is just as pertinent as it was nearly 100 years ago, it is time for us to experiment with new ways of communicating. We are talking with some of our new members to create videos, podcasts, and perhaps a virtual unit meeting. Given that the people we often times are trying to reach do not speak English, we need to translate some of our voters' materials into other languages. We began by translating *Facts for Voters* into Spanish, Vietnamese, and Korean because of a successful Go-Fund-Me campaign. We also need to reach busy people by producing articles and documents with less dense text and to put more of our information into bite-sized amounts on social media outlets.

Finally, given that nearly one-half of our membership is new, we need to focus on developing new League leaders to take on leadership roles. If you would like to become a new leader in our organization, please contact wendy.foxgrage@gmail.com, so she can pair you up with a mentor.

We hope to see you at our annual meeting on Saturday, April 21 and look forward to hearing from our keynote speaker, Tom Gjelten, author of *Nation of Nations*. Many thanks to all of our League volunteers. You are our greatest strength!

Prepare for Community Voter Registration Activities

2018 Election Voter Registration Deadlines:

- May 1 Town Elections - City of Fairfax and Towns of Clifton and Vienna voter registration deadline - April 9 at 5:00 p.m., ON-LINE: 11:59 p.m.
- June 12 Primary Election(s): voter registration deadline - May 21 at 5:00 p.m., ON-LINE: 11:59 p.m.
- November 6 General Election: voter registration deadline - October 15 at 5:00 p.m., ON-LINE: 11:59 p.m.

Bob Meredith will schedule voter registration training sessions on weekdays and weekends at the Packard Center as needed. Please check the Voter Registration SignUpGenius for dates and times as the year goes on. If all the places are filled, please come anyway.

Remember every year you must renew the State's registration training - it expires on June 30. Therefore if you were registering people in the Fall 2017, you can continue to register people until June 30, 2018. If you have **not** completed the Third-Party Voter Registration and Affidavit please do so - <https://www.elections.virginia.gov/registration/registration-drives/training-video.html> Note: until mid-year 2018 you are using the 2017 version of the training.

The 15-minute video is straightforward.

Underneath the PowerPoint slide show, on the same webpage, there is an instruction in green italics. Be sure to click on it to go to the Survey Monkey questionnaire, which is the Voter Registration Application Request and Affidavit. Note when submitting on-line click ONCE "submit", then WAIT TO SEE the "Application Submitted" notice.

After you have completed the application, you will NOT get a certificate or response but your name will be entered into the database for this year- remember that it expires on June 30, 2018. So you'll have to renew it promptly after July 1.

PROPOSED RULES OF PROCEDURE

The Rules of Procedure become the tools that permit a majority to accomplish its purpose within a reasonable period of time, but only after allowing the minority a reasonable opportunity to express its views on issues.

- I. LWV Bylaws and Robert's Rules of Order Newly Revised ("Parliamentary Procedure") generally guide the proceedings.
- II. Only members in good standing in the LWVFA will be permitted to speak and vote.
- III. **Discussion**
 - Speakers shall identify themselves by **name** and **unit**.
 - Each speaker will be allowed two minutes, unless otherwise announced.
 - The chair will not recognize a person the second time until all who wish to speak have done so.
 - Debate must be germane to the subject.
 - Members may request an extension of time.
- IV. **Motions and Amendments**
 - Lengthy motions and amendments shall be written and submitted to the Secretary.
 - An amendment may be amended only once.
 - As all agenda items require prior member notice, motions to amend the bylaws or program, which change the intent or enlarge the scope, will not be permitted.
- V. **Procedure for Program Adoption**
 - A. Informal consideration
 - a. An initial presentation of the recommended and non-recommended items is made.
 - i. Recommended items: Only questions of clarification will be permitted at this time.
 - ii. Non-recommended items: A member may give two-minute presentation recommending the item, followed by a formal Motion To Consider. A member of the Board may give reasons for not recommending the item (one minute.) The motion is then voted upon immediately. If it receives a majority vote, it is then **considered for adoption** on the same basis as the recommended items, except that it must receive 3/5 vote for adoption.
 - b. The proposed program (approved non-recommended items, followed by recommended items) is now up for informal consideration; there may be discussion, without formal motions, as time permits.
 - B. Formal consideration
 - a. Motion To Adopt is made.
 - b. Program: non-recommended items and then recommended items, in the order in which they were voted for consideration, are taken up one at a time for formal motion, further debate, possible amendment and vote.
 - c. Current Positions: members have an opportunity to reaffirm or reject current LWVFA positions. After an item listed is moved for adoption, a Motion To Strike Or Amend a particular position is made.

- Tom Gjelten covers issues of religion, faith, and belief for NPR News. His reporting draws on his many years covering national and international news from posts in Washington and around the world.
- In 1986, Gjelten became one of NPR's pioneer foreign correspondents, posted in Latin America and Central Europe. He covered the wars in Central America, social and political strife in South America, the first Gulf War, the wars in the former Yugoslavia, and the transitions to democracy in Eastern Europe and the former Soviet Union.
- After returning from his overseas assignments, Gjelten covered U.S. diplomacy and military affairs, with the State Department and then from the Pentagon. He was reporting live from the Pentagon at the moment it was hit on September 11, 2001, and he was NPR's lead Pentagon reporter during the early war in Afghanistan and the invasion of Iraq.
- A graduate of the University of Minnesota, he began his professional career as a public school teacher and freelance writer.
- His latest book is [*A Nation of Nations: A Great American Immigration Story*](#). It recounts the impact on America of the 1965 Immigration Act, which officially opened the country's doors to immigrants of color. It focuses on Fairfax County and was LWVFA's focus in January of 2018.

SUBJECT: Proposed General and Education Fund Budgets for Fiscal Year 2018-19

The proposed General Fund and Education Fund budgets for Fiscal Year 2018-19 appear on the following pages. The General Fund budget proposes operating expenses of \$74,031. Total income is projected to be greater than last year at \$50,270. Transfers from the Legacy Fund (\$11,000) and from reserves are anticipated to cover additional projected expenses, bringing the requirement for total income and transfers to \$74,580.

The good news: Our registered membership for FY 18-19 continues to grow and has reached 365 members--up from 278 last year. This brings in more receipts from dues. Unfortunately, over 75% of these receipts are paid out as the membership requirement to national, state, and regional Leagues, leaving us with less than 25% in support of our own operation.

In addition to an increase of nearly \$4,000 in the League per member payments (PMPs), the LWVVA Convention will occur in Norfolk in May of 2019. With our increased membership, we can send sixteen delegates to this important session. The estimated cost for registration and hotel rooms totals \$4,000.

The Education Fund budget projects expenses of \$22,458 for operations, slightly more than \$4,000 over last year. Over half of that increase is attributable to the 25% share of the General Fund's administrative costs charged to the Education Fund. This is budgeted to be \$10,833, but will depend on the actual cost through the fiscal year. We anticipate that some spending on Voter Services will be covered by the receipt of grant funds from LWVUS and LWV-VA.

Over thirty-five percent of Education Fund expenses are dedicated to Voter Service publications and materials, printing Facts for Voters, offering voter access to Vote 411, and supporting voter outreach for local and state elections.

We request your approval and your recommendation that the membership adopt these budgets in April.

Change title of Social Policies/**Juvenile "Problems"** to Social Policies/ **Juvenile "Justice"** and remove the word "problem" in reference to youth or juveniles in the text of the position wherever possible. **Example** – Position-in-Brief wording: "Support for measures to protect and rehabilitate *"problem"* youth; **delete word "problem"** to say: "Support for measures to protect and rehabilitate **youth.**"

III. **Recommended for concerted LWVFA ACTION:**

- **GOVERNMENT / Registration and Voting:** Continue "The Campaign for Making Democracy Work®" at the **LOCAL level** which includes ensuring a free, fair and accessible electoral system for all eligible voters. LWVFA will continue to reach out to underserved communities, work on voter education, protection, and mobilization; on improving elections; work for redistricting through a fair and nonpartisan process; and monitor local redistricting.
- **GOVERNMENT /Transportation:** LWVFA continued Action (in conjunction with other area Leagues) to promote and explain the importance of public transportation, especially Metrorail in Fairfax County, and the need for a permanent funding source for Metro.

V. **Not-Recommended Program Items**

Oversight Procedures of the Fairfax County Police Civilian Review Panel and the Independent Police Auditor

During the February 7, 2018, meeting of the Fairfax County Criminal Justice Advisory Board the Members heard from Adrian Steel, Jr., Chairperson of the County's Police Civilian Review Panel, and Richard Schott, the Independent Police Auditor (IPA) for the County. (These positions only deal with issues related to the Fairfax County Police Department [FCPD], not the County Sheriff's Department.)

As a result of the actions of a Fairfax County Police Officer in the shooting death of a civilian in Springfield, VA, a few years ago, and follow-up discussions by County citizens, the County Board of Supervisors (BOS), and the Police Department, it was decided that a formal oversight process should be put in place in the event of similar issues in the future. Therefore, during December 2016 the BOS approved the establishment of the County Police Civilian Review Panel (CRP), consisting of nine County residents.

During February 2017 the nine members were appointed by the BOS to whom they directly report. The purpose of the Panel is to enhance police legitimacy and to build and maintain trust between citizens, the BOS, and the Police Department by reviewing certain police investigations to ensure that the investigations are accurate, complete, thorough, objective and impartial. Responsibilities of the Panel include:

- providing an independent process for commencing an Initial Complaint against the FCPD or its officers;
- reviewing completed investigations of public complaints of abuse of authority or serious misconduct by a FCPD officer when requested;
- holding public meetings on issues within their jurisdiction and on law enforcement policies and practices;
- issuing reports on their activities and recommendations about FCPD policies, training and practices; and
- meeting with the Independent Police Auditor on his/her recommendations on use-of-force cases.

The jurisdiction of the CRP in regard to public complaints for abuse of authority or serious misconduct cases include:

- use of abusive racial, ethnic or sexual language or gestures;
- harassment or discrimination based upon race, color, sexual orientation, gender, religion, national origin, marital status, age, familial status, immigration status, or disability;
- acting in a rude, careless, angry, retaliatory or threatening manner not necessary for self-defense;
- reckless endangerment of a detainee or person in custody;
- violation of laws or ordinances; and
- other serious violations of the County or FCDP policies or procedures, including the FCPD Canons of Ethics, that occur on- or off-duty. (The word "serious" has not been defined.)

The Panel cannot review complaints when:

- they fall under the exclusive review of the IPA;
- the incident occurred before December 6, 2016;
- the initial complaint was filed more than one year after an incident (absent good cause);
- the review request was filed more than 60 days after the FCPD sent an "investigation complete" notice to the complainant; and
- there is a pending criminal or civil proceeding in any trial court (until that proceeding is over).

Also, as mentioned above, the Panel has no jurisdiction to review any complaints related to the Fairfax County Sheriff's Office nor can they review any federal law enforcement action (e.g., the Immigration and Customs Enforcement office). Additionally, the Panel cannot take testimony or receive evidence.

Steel told the Board that in Fairfax County approximately 40 percent of "use-of-force" incidents involved African-Americans while African-Americans make up only about eight percent of the County's population. He also said that there have been "a number of problems" with persons with mental health issues.

The Panel will not review a FCPD investigation unless a complainant is dissatisfied. Currently there are three pending FCPD investigations of complaints being reviewed by the Panel. Steel also told the Board that under Virginia law it is not clear if the BOS can delegate their authority to investigate FCPD activities to the Panel or to the IPA.

Schott, the IPA, is a County employee who has a staff assistant. He is a retired Federal Bureau of Investigation (FBI) agent and instructor at the FBI Academy, where he instructed on use-of-force and deadly-force policies. He

told the Advisory Board that the County is one of a small number of jurisdictions which have established both a Civilian Review Panel and an IPA.

The responsibilities of his position include:

- monitoring and reviewing internal investigations of police-officer-involved shootings, in-custody deaths, and use-of-force cases in which an individual is killed or seriously injured;
- monitoring and reviewing administrative investigations of use-of-force incidents when a public complaint is made;
- issuing public reports for each reviewed internal/administrative investigation and producing annual reports of those reviews;
- making public recommendations concerning revisions to FCPD policies, training and practices; and
- providing administrative support to the Civilian Review Panel and delivering the Panel's annual report to the BOS.

Schott said that he automatically reviews police internal investigations in cases of officer-involved shootings. He also does so if an officer's use of force results in someone's death or serious injury. He also reviews any other uses-of-force by a police officer if a complaint is made by a member of the public.

The IPA can also review incidents where there wasn't any force used by a police officer but a person in the custody of the FCPD dies.

The jurisdiction of the IPA, therefore, includes:

- an officer-involved shooting;
- an in-custody death;
- use-of-force incidents when a public complaint is made:
 - >FCPD policy describes "force" as including any physical strike or instrument contact with an individual or any significant physical contact that restricts an individual's movement but does not include escorting or handcuffing an individual who is exhibiting minimal or non-resistance; and that
 - >placing an individual in handcuffs as a restraint in an arrest or transport activity, the simple presence of officers or patrol dogs, or the police issuance of tactical commands do not constitute a reportable action of force.

Schott said that some of the complaint forms which he receives are also sent to the Panel for their review. As of the date of the meeting the IPA had initiated seven reviews. The Auditor's Website (see below) has two reports posted as

of the same date: one involving a shooting in Herndon and the other an arrest in the Annandale area of Falls Church. The IPA made policy change recommendations based upon these two incidents. The Police Chief is reviewing them. When asked whether he is getting support from the Police Department for the work that he is doing he said that the Department has "fully embraced" his work. A complaint may be submitted on a form found on-line by e-mail, mail or in-person.

Spring Renewal

Healthy Planet-Healthy People is the theme of SpringFest Fairfax, the County's Earth Day and Arbor Day event. See www.springfestfairfax.org/ for the complete schedule of April 21 activities at Sully Historic Site. You can picnic in Tudor Place's historic gardens on April 22 during its annual plant sale, featuring heirloom and native perennials, now including herbs and other edibles. Also, the Smithsonian will celebrate what is working in conservation, why, and how to replicate and scale up best practices April 16-22 using #EarthOptimism2018.

Nature can benefit your health. Japan officially recognizes taking in the forest atmosphere as a disease-prevention method. Some of the terpenes released by forests have been found to have anti-inflammatory, anti-tumorigenic, and neuroprotective properties. Their highest concentration is in summer, in the middle of the forest where the trees are densest, and when the air is moist, such as after rain or during fog. Also, the Journal of Adolescent Health reports that anti-depression benefits of living in areas with lots of natural vegetation applies to children as well as adults, particularly middle schoolers. Take yours and an educational

backpack borrowed from your library to visit a state park using its free parking pass.

You can benefit nature. Thanks to consumer demand, better environmentally-friendly products are available at lower cost. Consider purchasing:

- EPA-rated “WaterSense” shower heads for low flow with high-pressure
- Low-flow or dual-flush toilets
- Energy Star-rated washers and dishwashers when renovating

- Hybrid version when replacing a vehicle.

Also:

- Buy lasting products to replace disposables, such as switching to cloth napkins from paper.
- Avoid single-use products to cut down on packaging.
- Reduce your vulnerable monoculture lawn and add native plants, which need less water. Leave grass clippings on your lawn to help return nutrients to the soil. Water your lawn before 10 a.m. so the water won’t evaporate so fast.

February 25 Redistricting Forum Draws over 200 Participants

A redistricting forum sponsored by LWVFA and OneVirginia2021 and held on February 25 at the Sherwood Community Center in the City of Fairfax was a huge success! Panelists included Delegate Ken Plum, professors and students from the College of William & Mary Law School and the Center for Geospatial Analysis, and three Commissioners from California’s Citizens’ Redistricting Commission. Concluding remarks were made by Brian

Cannon of OneVirginia2021 and Olga Hernandez of the League. Over 225 people attended and many participated in the Q & A after each set of panelists.

Of special interest to the attendees was the presentation by the California contingent who walked the group through the details of the process they went through, highlighting things that worked and those that did not.

The William and Mary professors and students reviewed processes their groups used to create the 11th Congressional District that met compactness and fairness tests as applied by the court.

“Catalyzing Impact” Provides Funding for Translations of *Facts for Voters*

LWVFA recently worked with a startup, “Catalyzing Impact,” to raise funds to translate the 2018 edition of *Facts for Voters* into Spanish, Korean and Vietnamese – a project envisioned by Maggi Luca, the Editor.

The League started producing *Facts for Voters, A Directory of Public Officials and Government Offices* in the 1970s. It’s a compact reference guide that lists elected and appointed government officials, agencies and services along with contact information.

Stacy Brustin and Veronica Letelier founded Catalyzing Impact to help small, grassroots organizations with their fundraising. LWVFA and OneVirginia2021 were their first clients in Virginia. They said that they were impressed by what we do. They had checked out our website, our social media presence, and our events. They offered a hand with

fundraising for translating. We quickly wrote up a grant, estimating costs of \$4,500, which they accepted. Catalyzing Impact then set up a GoFundMe campaign. Many of us shared the campaign on our social networks and we ran an ad campaign on Facebook with a boosted post: [facebook.com/lwvfairfax/posts/1555320284554452](https://www.facebook.com/lwvfairfax/posts/1555320284554452)

The post not only resulted in donations but also in contacts with organizations in the communities we are targeting. The campaign raised almost \$3,000, and a D.C. foundation topped off the rest to meet our \$4,500 goal.

We worked with a company in Minnesota that Fairfax County uses for translations. Oakton-based translator, Lola Quintela translated FFV into Spanish. A new League volunteer, Karen Loehr, did the Spanish layout for us.

We have contacted teachers of English as a second language in Fairfax; many have requested PDFs. We will also reach out to the teacher liaisons and the Latino, Korean and Vietnamese communities in Fairfax.
