VOTE ABSENTEE BY MAIL BALLOTS

>>Witness signatures are NOT required on absentee ballots, but the last 4 digits of SSN and year of birth are required <<



- Vote by mail applications available at: Office of Elections, government centers, libraries, or apply online: elections.virginia.gov/voterinformation
- Mail your applications and voted ballot early in case USPS mail is delayed OR return to a monitored Drop Box at an early voting location during open hours, in front of the Fairfax County Government Center 24/7, or at any polling places on Election Day
- Absentee voters who choose to vote in person at a polling place on Election Day should bring and surrender the ballot received in the mail

Transportation Bonds: Shall Fairfax County, Virginia, contract a debt, borrow money, and issue bonds, in addition to the transportation improvements and facilities bonds previously authorized, in the maximum aggregate principal amount of \$180,000,000 for the purpose of financing Fairfax County's share, under the Washington Metropolitan Area Transit Authority Compact, of the cost of constructing, reconstructing, improving, and acquiring transportation improvements and facilities, including capital costs of land, transit facilities, rolling stock, and equipment in the Washington Metropolitan area. [Yes/No]

Public Safety Bonds: Shall Fairfax County, Virginia, contract a debt, borrow money, and issue bonds, in the maximum aggregate principal amount of \$126,000,000 to provide funds in addition to funds from public safety facilities bonds previously authorized, to finance, including reimbursement to the County for temporary financing for, the costs of public safety facilities, including the construction, reconstruction, enlargement, renovation and equipment of civil and criminal justice facilities, police training and operational facilities and stations, fire and rescue training facilities and stations, including fire and rescue stations owned by volunteer organizations, and the acquisition of necessary land.
