A draft of the Form 990 is available for review by the Finance Committee no less than one month prior to the due date. The Finance Committee has no more than two weeks to complete their review of the Form 990. The Finance Committee conducts a top-level or big-picture review. Once the initial review is completed, a meeting will be scheduled with the preparer to discuss any questions, comments, and suggested revisions identified by the Finance Committee. The preparer then makes any revisions necessary. All questions, comments, and suggested revisions are documented with any responses from the preparer. After the Form 990 has been reviewed by the Finance Committee and filed with the Internal Revenue Service, the Finance Committee will make a presentation at the next full Board of Directors meeting to update the full Board regarding its review of the Form 990. It is not required to review all of the questions, comments, and suggested revisions; a summary of the more important points is sufficient.

Board Members have instituted a procedure that each member must complete a Conflict of Interest Policy Questionnaire annually.
