## *Huntington Harbour Yacht Club*

### *House and Bar Policies*

#### **House Policies:**

1. HHYC members are entitled to club privileges as defined by the HHYC by-laws, including these house and bar policies
2. While at the club, yacht club members and their guests shall conduct themselves appropriately at all times. The HHYC Club Manager, Flag Officer, or officer of the day may ask anyone not in compliance with any HHYC policy, or who is acting inappropriately, to leave the premises.
3. Members may only invite guests to, or arrange for, guest usage of the Club in accordance with current Club policies and ABC regulations.
4. Guests and visitors are to register (sign in) at the front desk, or other designated area, before gaining admittance to the clubhouse. All guests must wear a name tag.
5. All guests must be accompanied by a member when on Club premises.
6. Children under ten (10) years of age are to be accompanied by an adult member while on Club premises, except for adult supervised programs (i.e.: Summer Sailing School). Children in the Clubhouse are to behave appropriately and in a manner that is not disruptive to others. No one under the age of 21 is allowed to sit at the bar. All children upstairs must be accompanied by an adult. The use of skateboards and roller blades is prohibited on Club Grounds.
7. The Clubhouse is designated as a non-smoking facility. Smoking is permitted outside the Clubhouse and away from doors where smoke can be blown back into the Clubhouse.
8. The use of cellular phones, or other mobile devices, is prohibited inside the Clubhouse for voice activities. These devices may be used for keyboard and camera activities only.
9. Any member may file a written report with the Board of Directors to complain of misconduct of another member or guest.
10. Members or guests shall not criticize any member of the Club's staff in front of other members or guests. Any such criticism should be directed to the General Manager, a Flag Officer or Director.
11. HHYC, as required by Federal and State law, has adopted rules governing sexual harassment and hostile work environment. HHYC does not tolerate verbal or physical contact by any employee or member which harasses, disrupts or interferes with another's work performance or creates an intimidating, offensive or hostile environment.
12. Any member or guest who damages or destroys any HHYC property is responsible for the costs of repair or replacement thereof.
13. Only a member in good standing can schedule an event in Club facilities.
14. During regular bar hours, the bar area will always be available to members, whether or not there is a private event in another part of the clubhouse.
15. No one is permitted to dispose, rent, borrow, or remove any property owned by the club without permission from the Club Manager or a Flag Officer.
16. Members should wear their name badge when at the clubhouse. Members **MUST** wear their name badge when consuming alcohol at the clubhouse. Members and guests may be asked to present identification at any time.
17. No pets are allowed in the Clubhouse. When pets are on the Club premises or dock area they must be kept on a leash, Owners of pets are responsible for cleaning up after their pets.
18. Nothing shall be mounted in any manner on Club walls or pillars without the permission of the club manager or a Flag Officer. All decorations or props that are used for social or other functions other than table centers or counter top items must be approved by the Club Manager or a Flag Officer before being installed. No confetti or like item is to be used at any time.
19. Nothing is to be posted on the bulletin or directory board without approval of a Flag Officer or club manager.
20. No member or guest shall knowingly interfere, breach, or cause damage to any contractual obligation of this Club. Members are responsible for controlling guests in this regard and are personally liable for any fine imposed by the Board of Directors, assessments of actual damages, including attorney fees and costs incurred by the Club, and any resulting damages paid by the Club arising from the conduct of such member or guest.
21. No person under twenty-one (21) years of age is allowed in the bar area unless accompanied by a responsible adult.
22. Use of the docks is under the control of the Club Manager or a Flag Officer.
23. In addition to other remedies, a late fee of 10% of the outstanding balance shall be added to annual dues or other moneys owed HHYC that are 30 days in arrears from the due date.
24. Member reservations at clubhouse functions are their financial commitment to that function. Event chairpersons, including cruise leaders, may determine the reservation cancellation policy for their event or cruise. The policy will be specific to that event or cruise only and may vary from event to event. The policy may call for reservations to be non-refundable after a specific time, fully refundable or any other alternative the event chairperson determines.

**2016 Huntington Harbour Yacht Club House and Bar Policies**  
**(continued)**

**Bar Policies:**

1. No one is permitted behind the bar except HHYC employees Flag Officers, or a person designated by a Flag Officer.
2. Bartender may refuse service to anyone, but shall refuse service to:
  - a. inebriated persons
  - b. anyone without nametag,
  - c. anyone under the age of 21 (twenty-one)
  - d. discourteous, unruly individuals
  - e. guests, unless accompanied by a member, and having signed the guest register
3. The bartender, or a Flag Officer, with the assistance of other members present, will make every attempt to arrange safe transportation for intoxicated persons leaving the Club  

On no occasion will alcoholic beverages be served between 2:00am and 6:00am. Bar will be open to members during regular bar hours without exception.
4. Bar can be closed by anyone that is permitted to be behind the bar with a key to the clubhouse..
5. All open bar tabs must be closed on the same day as service is received.
6. Only those alcoholic beverages purchased at the bar may be consumed on Club premises. Persons bringing alcoholic beverages to HHYC will be asked to remove them immediately from Club property or the beverages will be confiscated. One exception to this rule is unopened bottles of wine, which may be opened and served by the bartender for a corkage fee. With the exception of wine that has been re-corked, open alcohol beverages purchased at the Club cannot be taken off premises onto public roads.
7. Off sales of alcohol are not permitted.
8. No one under the age of 21 (twenty-one) will be allowed to handle alcoholic beverages, with the exception of unopened bottles not intended for consumption on the premises.
9. No one under the age of 21 (twenty-one) will be allowed behind the bar or be allowed to sit at the bar.
10. Minors are allowed in the bar area when accompanied by a responsible adult, and behave in a manner as to not disturb others.
