- Swim suit: All females are requested to wear modest, one-piece swimwear (tankini's allowed if mid-section is covered). A bikini with a black t-shirt over is allowed.
- Bible and Life Journal or regular journal and pen
- Summer clothing (Girls, no spaghetti straps or strapless tops, shorts must have at least a 2 inch inseam.)
- Game clothing (clothes that can get wet/dirty/stained).
- Prescribed medications (These will be turned into the camp nurse upon check in Tuesday morning).
- Money for snacks/souvenirs (optional).
- Clothes/costume for 80's themed party.

Camp Rules

- No weapons (including pocket knives), Alcohol or drugs (including ecigs)
- There is no cell service except for Verizon. Connect with Katie Weed for an emergency contact number.
- You may not be in a cabin/room of the opposite sex.
- No Devices! Camp is for focusing on God.
- Participation is expected in all activities and services.
- Campers may not leave their rooms/cabins after curfew.
- We have rented the Upper Campus, no going onto the Lower Campus except for free time and during designated games times.
- Do NOT walk along the railroad tracks.
- DO NOT enter the river unless lifeguards are present.
- Obey all posted signs (especially at the slide, water balloon launcher, etc)
- Do not write on bunks or walls.
- Throw all garbage away in trash cans (not outhouses), especially when on walks/hikes.
- Stay away from wildlife.
- Shoes must be worn on campus.
- No fires outside of designated pits.
