

## **Introduction**

Mitchell Spearman Golf (“We”) respect your privacy and are committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit mitchellspearman.com (“Website”) and our practices for collecting, using, maintaining, protecting, and disclosing that information.

## **Children Under the Age of 13**

Our Website is not intended for children under 13 years of age. No one under age 13 may provide any information to or on the Website. We do not knowingly collect personal information from children under 13.
