How?

Who is Sourcing Alliance?

- Sourcing Alliance is a Public Sector Group Purchasing Organization (**GPO**).
- We establish “piggybackable” supplier contracts with improved pricing and contract terms for a wide range of product and service spending categories.
- Public, private, and not-for-profit organizations join Sourcing Alliance to leverage any of these group purchasing programs.
- Association partners offer Sourcing Alliance group purchasing programs as additional member benefits.

Two Types of Contracts

Compliant Contracts

- Contracts explicitly established under public sector procurement guidelines. Public sector and federally funded organizations may leverage these cooperative contracts entities without having to conduct a bid/RFP process.

Negotiated Agreements

- Contracts established through an intensive vendor selection and vetting process that is more in keeping with the typical private business and non-profit organization procurement process.

OMB Procurement Guidelines

The Super Circular Section 200.318 General Procurement Standards paragraphs (d), (e), and (f) require that a non-Federal entity's procurement procedures avoid duplicative purchases and encourage non-Federal entities to enter into inter-entity agreements for shared goods and services, such as the agreements that Sourcing Alliance has established with its Supplier Partners:

§ 200.318 General procurement standards.

(e) To foster greater economy and efficiency, and in accordance with efforts to promote cost-effective use of shared services across the Federal government, the non-Federal entity is encouraged to enter into state and local intergovernmental agreements or interentity agreements where appropriate for procurement or use of common or shared goods and services.
