

## Online Privacy Policy for Sovereignty Herbs, LLC

Protecting your private information is our priority. This Statement of Privacy applies to [www.sovereigntyherbs.com](http://www.sovereigntyherbs.com) and Sovereignty Herbs LLC and governs data collection and usage. ### Collection of your Personal Information
