House Rejects Anti-LWCF Amendment

Washington, DC – The following statement may be attributed to Tom Cors, Director of Government Relations for Lands at The Nature Conservancy and a spokesman for the LWCF Coalition.

"We congratulate the House of Representatives for decisively rejecting Representative Biggs' attack on the Land and Water Conservation Fund (LWCF), America's most important conservation and recreation program. This misguided amendment would have robbed Peter to pay Paul, defunding key Bureau of Land Management conservation priorities to address just a tiny fraction of needed repairs in our national parks. That is an unacceptable and ineffective trade-off and we thank our many bipartisan supporters in the House who recognized this and voted "no".

"The conservation of our nation's shared outdoor heritage has always been an area of bipartisan agreement, as America's public lands are a defining aspect of our values and national character. LWCF is overwhelmingly supported by the American people, a fact which was reflected in the recently enacted Omnibus Appropriations Act, bipartisan legislation that increased LWCF funding.

"Rolling back critical investments in America's parks, lands and historic sites further jeopardizes irreplaceable natural and historic landmarks and landscapes while eroding increased access to outdoor recreational opportunities and increased access including access for sportsmen and women.

"The LWCF Coalition will continue to work with the Appropriations Committee and conservation champions in the House, and with their Senate counterparts, to protect America's most important conservation and recreation program into the future so that there is access to recreation for every American no matter where they live or play."
