Salon blo's Wedding Agreement includes the following:

- A surcharge of 15% added to all service costs to accommodate an early day (before regular Salon operating hours).
- 25% deposit is required upon booking your Bridal Services with us. Deposits for all services requested in this "Agreement" must be paid at the time of the booking. The Bride is responsible for attaining all the deposits but Salon blo requires only one payment. The balance is to be paid the day the services are rendered.
- Any changes to this "Agreement" or any scheduled appointments **must be made in writing and will be accepted up to one week prior to the wedding day.** Changes made with less than one week notice will be charged to the credit card associated with this "Agreement". Please be advised that the full cost of the cancelled service will be charged to the credit card.
- We will only accept changes for any arrangement or service contained in this agreement from the Bride.
- **All changes must be in writing or emailed to anna@salonblo.com.**
- A \$15.00 late fee will be applied for any member of the bridal party that arrives more than 15 minutes after their scheduled appointment.

Important Details:

- All attendants need to have clean dry hair at the time of their service. Our recommendation is to wash hair 24 hours before the service to ensure that your style will hold throughout the day. Any additional time spent washing or blow drying will be charged accordingly for the extra time spent. We suggest that the bridal party wear appropriate tops to avoid pulling clothing over top of the head.
