

Identifying your wool clip with the “Trade Mark for Excellence”.



MEMBERSHIP ID. STAMP - with the ASWGA Ram’s Head™ plus the members unique number and the Region ID. The self-inking stamp provided to financial members is imprinted on;

1) The Classer’s Specification sheet that accompanies your wool clip to your broker.

This is **ESSENTIAL** to ensure the data is collected and incorporated into the trading system which will enter your information as an ASWGA endorsed clip onto the catalogue informing buyers. The brokers Classer Specification sheet may differ in layout but the ASWGA stamp should always be placed in the BRAND box with the Station Brand.

2) The Bale Label on the top of each bale as shown here.

ASWGA RAM’S HEAD STENCIL - is provided to financial members to place on;

3) The face of each wool bale, positioned as shown.

ASWGA RULES FOR USE OF RAM'S HEAD TRADE MARK

For the benefit of ASWGA members and the status of their Wool Clip, the license to use the ASWGA Ram's Head™ is subject to Trade Mark protection laws. It is recommended that the complete clip have the Trade Mark attached to inform customers that the whole clip has true superfine breeding and is classed to the highest standards not only for fleece lines but also for skirtings, oddments, lambs etc.

BALE STENCIL & MEMBERSHIP ID. STAMP - *conditions of use.*

1. ASWGA will issue each financial member with a stencil and a pre-inking stamp with the Ram's Head Logo, members region and members unique number.
2. The stencil and the stamp are the property of ASWGA granted to a member as a license to use the registered Trade Mark on their own superfine wool under 19.5 microns.
3. Use of the stencil and the stamp will be as directed by ASWGA from time to time and use is subject to normal Trade Mark Laws. Misuse may result in cancellation of the license.
4. The stamp is to be used on the Wool Classers Specification Sheet and on the label on the top of the bale in association with the Station Brand. *Refer to the illustration on the previous page.*
5. The license to use the Trade Mark is an annual license issued on joining ASWGA and re-endorsed to financial members as at the 31st October in each year.
6. If a member is not financial as at 31st October the license will be cancelled unless prior arrangements are made with the Executive of ASWGA.
7. The license to use the Trade Mark is not transferable and any change in membership must be notified to the ASWGA office. If a member retires, sells his property or ceases to be financial as at the 31st October in any year then the stamp must be returned to the office of ASWGA and will be cancelled. Any change in membership will require the issuing of a new stamp.
8. Failure to comply with the conditions of use or deliberate misuse will be subject to Trade Mark protection laws.
9. Lost stencils and stamps will be replaced at the members cost. Stamps that have worn out or are damaged will be replaced provided they are returned to the ASWGA office.
