Why this parcel matters

Littlefield Woods, located in the heart of Chebeague Island, is perhaps the most important undeveloped parcel to protect on the island. The 25-acre property is unique because it features critical wildlife habitat; popular and historic recreational trails; an essential water recharge area; a large, important block of woodlands; and scenic interior forested views. The property lies adjacent to a geodetic marker which identifies the highest point in all of Casco Bay.

Maintains a connection to the past

In the 1800s, the Enoch Littlefield and William Thompson Family homesteads were located in the area. The cart paths were used to move materials and produce around the island as well as for residents to get from place to place, including to walk to church. Stonewalls, cellar holes, wells, and the paths from these times still remain on the landscape. More recently. the woodland has been well taken care of by the Bisharat Family, honoring Blanchard Bates' vision that this parcel must remain undeveloped to protect the island's important natural resources and aquifer. School children, camp groups, walkers, snowshoers, skiers, bikers, and hunters have all enjoyed these woods and trails over the years.

Preserves forest habitat

Littlefield Woods is part of the largest intact block of forest left on Chebeague. While much of the property was cleared in the mid 19th century to build boats and houses, there are many beautiful, large mature eastern white and red pine that were not harvested. The property also retains a wonderful, mature American horse chestnut tree as well as many oak, beech, maple, and spruce trees. The U.S. Fish and Wildlife Service has identified the woods as important for a large number of bird species including keystone species like American woodcock, ruffed grouse, wood thrush, ovenbird, blackburnian warbler, and pileated woodpecker. Other wildlife such as deer, fox, raccoons, snowshoe hares, and wild turkeys utilize these woods for habitat

Provides critical aquifer protection

Like much of Cumberland County, Chebeague Island is facing a high level of development threat. Islanders are concerned about the balance between development and a fragile island ecosystem with a coastline already being impacted by sea level rise. This concern is compounded by the need to protect the island's single source aquifer. Chebeague residents rely on the aquifer for clean drinking water. Protecting this aguifer is critical for the island's long-term sustainability and is identified as an issue of high importance in the Town's Comprehensive Plan. Littlefield Woods and other interior forested parcels along the spine of the island function as critical recharge areas for the aguifer. There is great urgency to protect these areas to ensure there will be clean drinking water well into the future.

Ensures a place for all to enjoy

For centuries, residents of Chebeague have enjoyed the trails in Littlefield Woods. The wide, relatively flat trail system, frequently used for hiking, nature observation, cross-country skiing, and snowshoeing, connects with the larger trail system on Chebeague via the Durgin Trail that CCLT protected with a trail easement in 2017. Hunters harvest deer and other wildlife in these woods as well. The forest also provides children and adults a chance to explore, learn, and play in a beautiful natural setting.
