Executive Message

Working with a family of electric cooperatives across the state and nation, Flint Energies is looking out for you, our members. That's the spirit that motivates our every action.

We're also driven to provide safe, affordable and reliable electricity. That's why we secured power contracts in 2008 that should support your needs into 2025. That's why we're negotiating with Houston County to use landfill gas as a renewable energy source. And, that's why we continue to upgrade power lines, manage right-of-way areas, install "SmartGrid" systems and add new substations.

Keeping our focus on what's best for you, we are using technology to improve the electric system efficiency and to keep you better informed. Communication improvements to our Web site, including a new outage map to track service restoration, are complemented by e-newsletters, text messaging, automated call warnings prior to cut-off, and energy-saving videos on YouTube.

In the spirit of efficiency, we're encouraging Flint members to sign up for "Switch N' Save." The program reduced peak electric demand by 19 megawatts in 2008, saving more than \$1.9 million.

During tough economic times, it's critical to make the best use of our resources. Our employees realize this and work hard to serve more members with a total workforce numbering less than in 2003. Despite the economy, the Flint Appliance Center finished 2008 in the black and our Elberta Road Office, which served members for nearly 40 years, was sold and continues as a vibrant community center.

Flint is looking out for you through member-elected leaders. It's appropriate to note two gentlemen who retired in 2008 after

representing members for a total of 40 years. Mr. Jimmy Wells of Ellaville, who passed away shortly after leaving the Board, exemplified consideration for the best interest of Flint members. He is remembered for bringing specific needs of individuals to Board meetings during his 25 years of service.

Mr. John Neely, Jr. was Chairman of the Board when he stepped down after serving more than 15 years as a representative from Taylor County. He received the Spirit of Flint award for his extraordinary dedication to the cooperative. It's this kind of spirit, commitment and service that sets us apart as a member-led organization.

Through a long-term strategic focus on managing Flint Energies wisely and effectively through dedicated leadership, we are committed to the people who own this cooperative. You're part of this family, and we're looking out for you.

Creating Jobs

When Flint Energies injected \$740,000 to Arriscraft to support expansion of their architectural stone facility in Crawford County, the co-op helped fund 30 new jobs. The co-op worked with the U.S. Department of Agriculture (USDA) to secure business development funds in the form of a zero-interest loan.

As a not-for-profit electric cooperative, Flint then passed the loan proceeds to Arriscraft to finance the new job creation effort. The company is making a total investment in heavy equipment for a \$9 million expansion and will pay the cooperative back over the next 10 years.

“We are pleased to participate with USDA Rural Development in helping finance this business expansion of Arriscraft,” said Flint Energies CEO Bob Ray. “Arriscraft has capitalized on the unique resources of this area for several years and is a good example of a community leader producing quality products and providing increased economic opportunity.”

The Rural Economic Development Loans and Grants (REDL&G) program provides funding to rural projects through sponsoring electric cooperatives. Flint is responsible for repayment of the loan to USDA, and Arriscraft has provided sufficient collateral to Flint to cover the loan. Though there are many USDA loan and grant programs for economic development, rural electric cooperatives are the only channel for local businesses to receive REDL&G funding. This was the first such program loan made through Flint Energies and one of the first in the state.

Opened new remote payment station locations at Atlantic Southern Bank locations in Roberta, Byron & Bonaire.

Locked down a power supply agreement with Morgan Stanley to purchase a 50-megawatt block of power for the time period 2015-2025.

Ranked second best in the nation by small and medium business accounts among 56 Touchstone Energy co-ops in 20 states.

September

Interconnected first solar power generator owned by a Flint member.

Recognized as one of the national leaders for prescription drug savings thanks to the Co-op Connections Card program, which helps Flint members save money on a variety of purchases.

Selected by Houston County to enter final negotiations for landfill gas to electricity project.

October

Featured on cover of the nationally distributed *RE Magazine* through story on Fort Benning operation.

Hosted Governor Perdue and Atlanta Brave John Smoltz at the Member Center as Warner Robins "pitched" Little League International on selecting the city to host the Southeast headquarters.

November

Recognized in *RE Magazine* for metals theft initiatives and participation in an area coalition.

December

Exceeded the average for co-ops surveyed in the Southeast for reliability of electric service.

Received confirmation that the co-op reduced the Flint summer peak demand for electricity by approximately 19 megawatts, saving Flint members more than \$1.9 million in demand charges through the "Switch N' Save" program.

Saving Lives

AI Williams and Lee Hollis, linemen with Flint Energies, were headed to rabbit hunt in Upson County, when they saw smoke billowing from a house. The two men stopped to help others who were trying to contain the growing fire. Williams and Hollis asked if anyone was in the house and were told “no.”

“We went in the house to try and recover a few items, and we started going down a hallway. I don’t know what made me look in one of the bedrooms, but there happened to be an elderly woman in there asleep,” says Williams. He quickly wrapped the woman in her blankets and carefully escorted her to safety. “I put her in the truck because it was so cold outside.”

Unfortunately, the house burned to the ground before the fire department could arrive, but Hollis and Williams are glad that they were there to help the elderly woman from the fire. Flint Energies management credits Williams’ and Hollis’ quick thinking and composed reaction to saving the woman’s life.

“We train our employees in life-saving and emergency techniques, so they can be equipped at any time, in any situation that might call for emergency response,” said Randy Lowe, *Safety and Job Training Coordinator*. “It’s an integral part of our overall safety program, because we understand that accidents, illness and disasters do happen, and we want to prepare employees to take the proper action, even when they are not at work.”



Operation Round Up

In 2008, the Flint Energies Foundation continued to help worthy organizations through the generosity of members participating in Operation Round Up®. The program encourages Flint Energies members to “round up” their electric bills, donating the resulting change each month. The proceeds fund the Foundation.

The Foundation awards grants to deserving local charities and service organizations, as well as worthy community projects, in a 16-county service area.

Some of this year’s grants have been used to purchase or provide:

- Construction materials to remodel a historic building and an arboretum
- Personal safety devices, “Jaws of Life” and other priority firefighting equipment to equip several local volunteer fire departments
- Supplies to make repairs and improvements to houses for the elderly
- Protective gear and digital video recording equipment for police departments
- Books and other library materials for an elementary school media center and for a new library at the Taylor County Campus of Flint River Technical College
- Canned goods for a food bank
- Home-delivered meals to senior citizens
- Equipment for children with special needs
- Uniforms and equipment for a myriad of youth sports programs
- Books for several libraries and literacy programs
- Scholarships to a local college and technical school.

The Foundation continued growing its Bright Ideas program, which provides funding for innovative

teaching projects not funded through the regular school budget. 13 grants totaling \$10,000 to teachers in Houston, Macon, Marion, Peach and Taylor counties will allow students to learn in exciting and creative ways. Since 2006, Flint’s Bright Ideas program has distributed nearly \$25,000 in classroom grants.

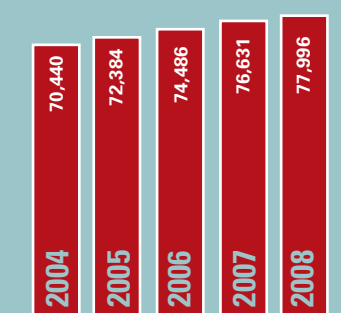

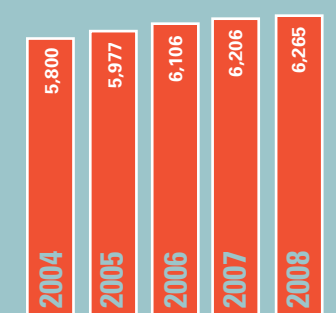
