

Summary

Our census of community foundations continues to show strong growth for the field. We estimate that assets at all 833 community foundations in the United States grew to about \$143.9 billion in 2021, an increase of nearly 13% over the 2020 level of \$127.4 billion. In the five years from 2016 to 2021, assets at community foundations soared 58% (from a level of \$91.2 billion in 2016).

A Note on Data Collection

Data for the community foundation census comes from several sources:

- "The Columbus Survey", a self-reporting survey formerly conducted by the Columbus Foundation and now overseen by CF Insights, which is part of Candid¹;
- Audited financial statements;
- Form 990 data, generally retrieved from GuideStar or ProPublica; and,
- In a small number of cases, estimates were used due to delays in financial reporting by community foundations.

Our 2021 survey includes actual information for all community foundations for the years 2016-2019. Information for 2020 and 2021 is an estimate based on a sampling of representative community foundations and could change as actual data is released.

In addition – we know that, despite our best efforts, errors can and do occur. If you see information that is incorrect, please contact us and we will correct the data in future releases of community foundation census data.

¹ While the data gathered by CF Insights contains a lot of valuable research on community foundations, only 238 of the known 833 community foundations responded to the survey in 2019.

List of Largest Community Foundations Relatively Unchanged

For the fourth year in a row, the Silicon Valley Community Foundation remains the largest community foundation in the United States. The relative ranking of other community foundations in the top 20 has changed little since 2016.
