Dear Interested Public:

The Ashland Field Office, Medford District Bureau of Land Management (BLM) is requesting public comments on the Bear Grub Vegetation Management Project Environmental Assessment (EA). The Bear Grub project is located on BLM-administered lands near the community of Ruch and southwest of the city of Medford, in Jackson County, Oregon. The EA includes an analysis of proposed vegetation management activities on up to **4,910 acres** of BLM-administered land, which includes:

Hazardous fuels reduction treatments (i.e. small diameter thinning and prescribed fire) on 3,465 acres.

Timber harvest (i.e. selection harvest, commercial thinning), and follow-up activity fuels treatments on up to 1,445 acres.

The BLM analyzed three action alternatives and a No Action Alternative in the EA. The action alternatives (Alternatives 2, 3, and 4) differ in the type of harvest prescribed or the amount of retention prescribed.

All substantive comments received by the date above will be considered before the BLM reaches a decision to the extent feasible (40 CFR 1503.4). Specific and substantive comments are the most helpful. Substantive comments do one or more of the following:

- Question, with reasonable basis, the accuracy of information in the EA;
- Question, with reasonable basis, the adequacy of, methodology of, or assumptions used for the EA:
- Present new information relevant to the analysis;
- Present reasonable alternatives other than those analyzed in the EA that meet the purpose and need;
