Penta's Dance 4 Mobility 2020 Challenge: Rules, Terms and Conditions

- Contest Overview: Thank you for your taking part in Penta's 2020 Dance Contest!
 Dance 4 mobility is a dance competition supporting Penta Medical Recycling.
 Individuals will be submitting dance videos which will be judged by Penta's executive team, and a select few will be chosen to win the prize tier in which the videos are submitted under.
- 2. Use of Proceeds: Proceeds will be used to fund Penta Medical Recycling's annual operational budget. Ultimately, this funding will go to support Penta Medical Recycling and its effort to repurpose prosthetic devices for amputees around the world.

3. Eligibility:

- a. Age: To participate in the Contest, you must either be either (i) 18 years or older (or the age of majority in your jurisdiction of residence, whichever is older) or (ii) have the consent of your parent or guardian.
- b. Location: The Contest is open to participants in the United States and worldwide, subject to all applicable national, state and local laws and regulations and void where prohibited by law.
- c. - 6. Entries: All entries must be videos produced by you. The video must at least 10 seconds long and at most 1 min in length. You are responsible for ensuring your video complies with all applicable requirements, including (i) obtaining the permission of those appearing in your video, (ii) obtaining permission for music and other media used, and (iii) complying with Instagram's terms and conditions and all other policies applicable to sharing content on Instagram. Penta reserves the right to disqualify your entry in its sole discretion at any time if it determines you have not complied with the applicable policies. By entering this content, you

acknowledge and agree that complying with such policies is your sole responsibility.

7. <u>Donations and Prize Eligibility</u>:

- judged by Penta's Executive Team and Participants from Penta's sponsors. The judges will use the following criteria in determining the winning videos: 60% based on participant talent in the video, and 40% based on video design.
- 9. Winner Notification: Winners will be notified by Instagram direct message and email by November 1st, 2020. If a winner cannot be contacted with the contact information provided, is ineligible, fails to claim the prize within 10 days from the time award notification was sent, or fails to timely return materials necessary to receive the prize, the prize may be forfeited and an alternate winner selected. Receipt by a winner of the prize offered in this Contest is conditioned upon compliance with any and all national, state, and local laws and regulations.
