(the "Participants") WAIVE, RELEASE, and DISCHARGE LYNNVANDER ESCAPES INC., its owners, officers, directors, employees, members, agents, assigns, legal representatives and successors, and all business associates and partners involved in the presentation of the above noted activity and each of them their owners, officers and employees, from all liability for or by reason of any damage, loss or injury to person and property, even injury resulting in the death of the Participant, which has been or may be sustained in consequence of the Participant's participation in the activity described above, and notwithstanding that such damage, loss or injury may have been caused solely or partly by the negligence of LYNNVANDER ESCAPES INC.

Each of us, individually, understand that being permitted to participate in the above noted activity, there are potential risks including but not limited to:

- 1) Being enclosed in a small room with up to twelve persons;
- 2) Passing through narrow openings and corridors;
- 3) Mental stress and similar disorders;

- 7) Lifelike environmental conditions, such as dust, temperature changes, and similar tricks;
- 8) Possibility of failure to solve the puzzle in the allotted time.

We have no physical or mental condition that precludes our participation in a safe manner for each of us or others. We are not under the influence of drugs or alcohol which impairs our ability to maintain our safety awareness or endangers others.

We acknowledge that this Accident Waiver and Release of Liability Form will be used by the organizers of the activity in which we may participate, and that it will govern our actions and responsibilities at said activity. We agree that all staff or authorized agents may, in their sole discretion, determine it is unsafe for each of us, or others, for our participation to continue, remove us from the premises by any lawful means.

In consideration of our application and permitting us to participate in this activity, we hereby take action for ourselves, our executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) WE WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for death, disability, personal injury, property damage, property

theft, or actions of any kind which may hereafter occur to any of us, THE FOLLOWING ENTITIES OR PERSONS: The directors, officers, employees, volunteers, representatives, and agents of any and all entities authorizing this activity;

(B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise.

We acknowledge that while we are participating in the above noted activity, we will be monitored by video camera and may be photographed after participating in the activity described above. We hereby consent to give LYNNVANDER ESCAPES INC., permission to allow photographs to be displayed, published or distributed.

We acknowledge that we are liable for intentionally damaging any items at LYNNVANDER ESCAPES INC.

We acknowledge that we are not permitted to take photos while participating in the activity described above.

We acknowledge that we are to remove outwear and leave all keys, tools, implements, and electronics on our persons in a protected storage locker while participating in the activity described above.

We acknowledge that we are at least 18 years old. (If a participant is under 18 years old, a Parent/Guardian must sign this contract.)
