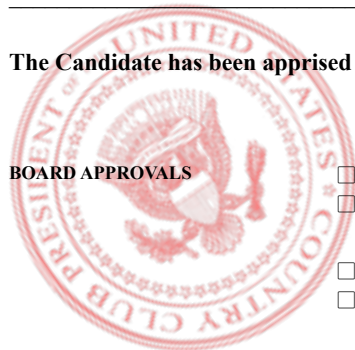

## TERMS — CONDITIONS — PRIVILEGES OF MEMBERSHIP

All candidates for MEMBERSHIP in MAR-A-LAGO are subject to the following terms, conditions, privileges, restrictions, security clearances, ambassadorships, political appointments, and pay-for-play opportunities. Candidates for all classes of membership shall pay an initiation fee of \$200,000.00. THE DUES FOR THIS CLASS ARE \$2,000.00 PER MONTH, PAYABLE IN ADVANCE THROUGH A BANK OF CYPRUS EXPENSE ACCOUNT, A CHOCOLATE CAKE AND RITALIN MINIMUM OF \$500 PER MONTH, BILLED QUARTERLY, AND A QUARTERLY SERVICE CHARGE IN LIEU OF 15% GRATUITY OF \$75.00.

Membership in MAR-A-LAGO does not require a state I.D., U.S. passport, social security number, birth certificate, completed Consular Report of Birth Abroad (FS-240 or FS-245), completed GSA Form SF-86, completed I-94 or I-94W, or utility bill. You rich? You good. Membership does not make the member financially responsible for any obligation of the Club. Likewise, membership does not confer upon a member any right, ownership or interest whatsoever in any property or appurtenances of the Club, nor does it confer plausible deniability of grifting, graft, or fiduciary slap-and-tickle. As a Candidate, or an accepted Member, it is understood and agreed that as such the Candidate and/or Member does not acquire, maintain or establish any vested rights, undefined privileges of equity in the Club or in the Membership therein. Management reserves the right to hide membership rolls from the public until such time that it would be advantageous to reveal them. Management also reserves the rights to define conditions of credit limitation and use reasonable means in the collection of accounts including public posting, collection agencies, threatened lawsuits, harassing pre-dawn tweets, and obnoxiously aggressive handshakes to let you know who's boss. Initiation fees are not refundable or transferable. Refunds may take four to five business years. Fuck you.
