# Pathologies of Power Paul Farmer, M.D.

- ► The illegal trade in children being raped and violently abused is at "<u>a level of epidemic</u> <u>proportions</u>" according to an internal government memo obtained by The Canadian Press. (2016)
- ► FBI's Assistant Director of Criminal Investigation <u>Joseph Campbell</u>, says <u>child sex trafficking and pedophilia</u> have reached <u>epidemic levels</u>. (2015)
- In June 2017, the national police in the Netherlands issued their Annual Trend Report, describing, for the first time, child pornography as a "threat to Dutch society." (2017)

This book is the result of a difficult journey. It is not research I wanted to do. It is research I have been compelled to do.

I have learned more than I ever wanted to know about how pedophiles destroy our children, families and communities.

This knowledge has altered how I view the world and changed how the world regards me.

It has cost me a great deal. I have lost friends. My career has been targeted. My ability to earn a living has been restricted.

I have persisted because this is a labor of love for children and adult survivors harmed by this crime and for dedicated investigators and prosecutors working to achieve justice.

### **Common Predator Profile**

A pedophile is not someone you look at and fear for your children's safety.

A pedophile is someone you willingly leave your child with because this is a person you trust.

Pedophiles are close to home, familiar and in positions of power over children.

Men, and it is overwhelming men, who trade in child rape "are for the most part educated, intelligent individuals who are well integrated into society and successful in other areas of their lives."

### **Common Predator Profile**

Child exploitation rings led by fathers have become, what some are calling, a "widespread tragedy."

Most child pornography is produced in North American and Europe. Children in North America and Europe appear to be targeted by their parents, most often their fathers, and are frequently "shared."

White men in leadership positions, often fathers, frequently involved in infant and toddler rape.

This appears to be the average pedophile profile.

### White Men in America

There is a prominent racial element to the trade in child rape and torture.

According to the <u>US Sentencing Commission's</u> most recent data <u>more than 85 percentage of all child pornography</u> convictions in the US were of white men.

This is a staggeringly significant racial demographic.





Figure 1.1 Total number of identified offenders and victims by nationality from the beginning of the ICSE database until 1 June 2016 (Source: INTERPOL ICSE).

### **Project Spade**

An investigation called Project Spade, a 2013 Canadian and US Postal Inspection joint operation, provides helpful examples of average pedophile profiles.

Toronto's Sex Crimes Unit said "Of concern to the investigators was the number of people who have close contact with children. The arrests included 40 school teachers, nine doctors and nurses, 32 people who volunteered with children, six law enforcement personnel, nine pastors or priests, and three foster parents."

All in just one investigation.

### **AP's Military Investigation**

Daily Images of Infants Raped

- Infant and toddler pornography is the rape and torture of children under four-yearsold.
- As early as 2009, the Department of Justice (DOJ) warned America that infants and toddlers were being raped in increasing numbers.
- By 2016, DOJ acknowledged it is "routine for child pornography investigations to include files depicting the sexual exploitation of infants and toddlers." This includes newborns - "children as young as days old."
- "Each day (we) receive imagery depicting infants being sexually abused," says Australian Federal Police Child Exploitation Assessment Centre Commander Lesa Gale. The US Department of Justice says infant and toddler rape is now "routine." (2017)
- One pedophile father, for example, posted to a child pornography trading site a sonogram an unborn child and a text message "I have a new baby about to be added to the game."

### Jon Riveire

Riveire was arrested, May 2015, and charged with six felony child pornography counts. He was trading in child rape, including of toddlers, on university computers. He pleaded guilty to one count, November 2016, in exchange for having the other charges dropped and was sentenced, February 2017, to 2.5 years house-arrest with no jail time.

He must register as a sex offender. Although Riverie is prohibited from contact with children under 16-years-old, the judge made an exception for Riverie's own children, one of whom is two-years-old, allowing Riveire to retain unsupervised access to his toddler-age children.

This kind of judgement, routinely seen in family courts, makes no sense. Why would a judge provide unsupervised access to a two-year old child for a criminal convicted of child sex offenses?

The text conversation continued for a period of time and arrangements to meet and have sexual intercourse developed. #### Kathleen Kane

"Kane referenced those emails again on Thursday, claiming she delivered this week more than 1,500 emails from a Supreme Court justice to the state Ethics Commission, the Judicial Conduct Board and the Disciplinary Board. "Those emails contained both sent and received emails from a present Supreme Court justice. They contained racial, misogynistic pornography," Kane claimed without naming the justice. "There's other emails regarding 30 percent of women are killed or murdered by their husbands or boyfriends and the punchline is 'well 30 percent of them should have just shut the expletive up.' "I'm not the woman to shut up. It is my job as attorney general to make sure that this commonwealth is run properly and the people of this commonwealth are protected. The images themselves aren't the only story. The problem is the network that's involved and the breath of this network is incredible," Kane added."

### Kathleen Kane

"You can arrest me two times, you can arrest me 10 times. I'm sure this isn't the end of the game, but I will not stop until the truth comes out, and I will not stop until the system operates the way it's supposed to be." "And what does this mean to the public?" "That means that your system, your criminal justice system that you think you have and you think you deserve is not working properly."

### Australian MP Dr. Rachel Carling-Jenkins

"I personally viewed deeply distressing images that have caused me immediate and ongoing anguish," she said.

"The faces of many [little girls] are etched in my memory for eternity and I pray the police are able to identify and rescue as many of these poor helpless and vulnerable victims as soon as possible.

"I find myself now unconsciously searching the faces of little girls on the streets, distressed when a face triggers a memory of a photo or a video of a little girl that I glimpsed in his collection.

"These little girls have lost their innocence their childhood and their control over their destiny."

File Name: Casey Abduction.avi

The first image depicts a female child's anus and vagina. The child appears to be an infant based on her relative size and lack of body or pubic hair. There is an adult hand on the infant's right buttock and there is an adult erect penis penetrating the infant's anus.


The second image appears to have been made using night vision and depicts a nude male child lying on his back. The child appears to be of infant or toddler age based on his relative size, lack of body hair and undeveloped penis. There is an adult penis penetrating the child's anus.

The third image depicts a female child lying flat on her back. The child appears to be prepubescent based on her relative size and total lack of body or pubic hair. The child is not wearing pants and her shirt is pulled up to her chest, covering her breasts. There is an adult penis penetrating the child's vagina.
