



Waiver/Code of Conduct

I am the parent/caretaker of the applicant. I consent to allow my child to participate in Highland Park Tennis Association's Tennis Program.

1. ASSUMPTION OF RISK. Participation in or attendance in Highland Park Tennis Association (HPTA) events involve inherent risks and dangers of accidents, personal and bodily injury (including death) and property loss or damage. These may result from my own or my child's actions or inactions, as well as known to me and not reasonably foreseeable at this time. I have considered the nature and extent of the risks involved, and I voluntarily choose to assume all such risks, both known and unknown, even those risks that result from the negligence of the Released party or others and assume full responsibility for my participation in such events.

In an effort to minimize risks, I agree to follow all safety rules/requirements.

2. RELEASE OF LIABILITY. I, for myself and on behalf of my heirs, estate, insurers, successors and assigns, hereby release, indemnify and hold harmless the United State Tennis Association, the Highland Park Tennis Association (HPTA), their respective officers, directors, employees, agents, representatives, assigns, insurers, all Event sponsors, advertisers, volunteers, staff, and all owners, or lessors of the premises (Highland Park Tennis Courts - NYC Parks Department) collectively the "Released Parties", with respect to any and all claims or causes of actions I and/or my child may have for damages for personal or bodily injury, disability, death, loss or damage to person or property relating in any way to participation in HPTA events, whether arising from the negligence of any or all of the Released Parties or otherwise, to the fullest extent permitted by law.

3. I grant HPTA and its affiliates, permission to film photograph, videotape, and film my child, and the right in perpetuity, to use my child's name, likeness, biographical information, and voice in all forms of media in connection with HPTA advertising, promotion, social media.

CODE OF CONDUCT

All participants of HPTA shall demonstrate their respect to the association by:

- * Observing HPTA's Junior Tennis participants' dress code at all HPTA practices, activities and events. Dress code consists of HPTA shirt/black bottoms, proper tennis footwear.
- * Being on time for assigned lesson, excessive lateness and absenteeism will not be tolerated.
- * Listening to and following coaches' instructions on lesson plans and safety.
- * Treating all other participants of HPTA's Junior Tennis Program with respect and dignity.
- * Abiding by all rules of tennis.
- * Avoiding abusive language, gestures, aggressive behavior. Such behavior will not be tolerated.

- * Conducting yourself in a positive manner at all times.
- * Promoting and supporting honest effort, skilled performance and improvement.
- * Demonstrating respect for opponents and their skills.
- * Treating the Highland Park tennis grounds/courts and facilities with respect and care.
- * Presenting a positive model of social harmony within the association.
