



How to Apply for a Day Pass

The Michigan Flower Growers' Cooperative market aggregates locally-grown flowers and foliage in a once-weekly wholesale marketplace open to florists and industry professionals. A buyer's pass is required to shop wholesale at the MFGC Market.

Individuals looking to purchase flowers for a wedding or special event may purchase a Day Pass to the MFGC market. **The Day Pass gives access to the region's only wholesale flower marketplace featuring exclusively Michigan-grown flowers and foliage. The MFGC aims to offer the most diverse and highest quality floral goods possible.**

Day Passes are granted for one market day only, of your choosing. Markets are held every Wednesday from April through October.

Benefits of the MFGC Day Pass include:

-Opportunity to purchase flowers and foliage at wholesale cost, often 50% of what you would pay at a retail florist.

-Access to a preorder sheet one week prior to your event date. The preorder sheet aggregates variety information, pricing and availability from all of the coop's 14+ grower members. You will be able to place an order from this sheet.

-Ability to shop the market floor, which often features varieties and colors that are not listed on the preorder sheet.

-Consultation and support services from the MFGC Market Manager. Day Pass holders are encouraged to contact the MFGC as early as possible to begin the planning efforts for their event. The MFGC Market Manager will work as a liaison between Day Pass holders and the MFGC grower members to coordinate crop planning and availability for your event.

Day Pass holders are required to pick up and pay for pre-ordered items at the market if the items are delivered as described. Items may be rejected and not paid for **ONLY** in the event that a pre-ordered item is not as described (variety, color or stems length differs from description on

the pre-order sheet). No refunds for delivered items will be made after payment.

The MFGC does not supply buckets for purchased bunches and stems. You are encouraged to either bring your own buckets or bring home stems dry. The MFGC may at times offer used buckets for purchase at a low cost, depending on availability.
