



## **How to Apply for a Buyers Pass**

A Buyer's Pass is required to shop wholesale at the Michigan Flower Growers Cooperative Market. Professional floral buyers and other business owners are eligible to apply for a buyer's pass. The buyer's pass is good for one market season, and must be renewed annually.

The Michigan Flower Growers Cooperative aims to offer the most diverse and highest quality Michigan-grown floral goods possible. Our flowers and foliage benefit from not being shipped far distances, and exhibit superb freshness and long vase life compared to commercial stems. The buyers pass grants access to the cooperative's weekly wholesale flower market as well as a weekly availability sheet for pre-orders from growers.

Pre-Orders are managed online. Upon completion of this application you will receive instruction from the Market Manager on how to access and use the Pre-Order spreadsheet. Pre-Orders may be made up to one week in advance of the market date for which you will pick-up. Pre-ordered items must be picked up at the market

Pre-Ordered items must be paid for on the day of market if the items are delivered as described. Items may be rejected and not paid for **ONLY** in the event that a pre-ordered item is not as described (variety, color or stems length differs from description on the pre-order sheet). No refunds for delivered items will be made after payment.

The MFGC does not supply buckets for purchased bunches and stems. Buyers are encouraged to either bring their own buckets or bring home stems dry. The MFGC may at times offer used buckets for buyers to purchase at a low cost to bring home their stems.

### **Buyers Purchasing Products for Business Purposes other than**

**Resale\* Must Provide:**

- A federal tax ID # or EIN
- Completed Buyers Pass Application
- \$100 fee

\* Please note that without a federal tax ID# or EIN, we are required to charge sales tax on all purchases.
