

Cambridge Centre for Animal Rights Law

The Cambridge Centre for Animal Rights
Law was started in 2019 as an educational
charity with the goal to advance the study
of fundamental rights for animals. The
Centre has three main pillars: research,
teaching, and outreach.

One of the teaching targets of the Centre is for 100 universities to be teaching an Animal Rights Law course in 5 years. In order to reach this goal, the Centre supports Law Lecturers' Workshops to help law lecturers design and teach their own Animal Rights Law courses.

Law Lecturers' Workshop 2023

The next Workshop will be held in May in Burlington, VT, in collaboration with the Animal Law and Policy Institute at Vermont Law and Graduate School.

The Workshop will be given by Dr Sean Butler (Fellow, St Edmund's College, Cambridge and Affiliated Lecturer, University of Cambridge, UK) and Dr Raffael Fasel (Affiliated Lecturer, University of Cambridge, UK), who together teach Animal Rights Law as part of the undergraduate Law degree at the University of Cambridge.

Drs Butler and Fasel have also written the first textbook on Animal Rights Law, which is forthcoming in March 2023.

In the Workshop, Drs Butler and Fasel will share all the course materials from their Cambridge University course, discuss strategies of how to put together an Animal Rights Law syllabus, and look at what readings to include and how to involve students.

Participants will develop their own Animal Rights Law course outline during the Workshop. On completion, participants will receive a certificate confirming successful completion of the course and will join the growing Animal Rights Law Teaching Network – an online community of global Animal Rights Law teachers.

Applying

Target group

The workshop is open to anyone interested in teaching an Animal Rights Law course at an undergraduate, graduate, or law school. Preference will be given to candidates teaching as a full-time or adjunct professor at *US and Canadian schools*, but applications from other candidates will also be considered.

Up to 12 participants will be selected for the workshop in Burlington, Vermont on May 8-12, 2023. There is no fee to attend the workshop; however, participants are responsible for their own travel and accommodations (rooms at a nearby hotel are blocked for \$209 per night.)

The Centre will provide all lunches and two dinners during the workshop. There are limited hardship funds of up to \$750 per person for participants who are not able to secure funding for travel or accommodation.
