Membership Agreement – Terms and Conditions

General Terms and Conditions

“access card” means the card issued by The Shooting Academy Listowel, which allows a patron to enter The Shooting Academy Listowel Range and Training facility outside of regular, staffed hours.

“The Shooting Academy Listowel”, “The Shooting Academy”, “TSA” and any representatives, subsidiaries, agents, employees and assignees of same.

“Patron”, “You”, and “Yours” means the membership patron named herein.

“Regular, Staffed Hours” means the hours posted, which staff are on premises that the facility is not locked on a regular basis.

1. The Shooting Academy Listowel and the patron agree that the patron shall be granted usage of the equipment and facility at The Shooting Academy Listowel in exchange for the payment of the fees herein.
2. It is understood and agreed that this agreement and the services and facilities provided thereby are not assignable or transferrable by the patron and no rights or privileges granted by this membership can be transferred or assigned at any time. The shooting Academy Listowel may assign this agreement at any time at its sole discretion.
3. By the use of the facilities at The Shooting Academy Listowel and of the attendance at The Shooting Academy Listowel, the patron expressly agrees that The Shooting Academy Listowel shall not be liable for any damages arising from personal injuries sustained by the patron in, on or about the premises, or as a result of the patron using the facilities and the equipment therein. By the execution of this agreement, the patron assumes full responsibility for any injuries or damages which may occur to the patron in, on or about the premises and further agrees that The Shooting Academy Listowel shall not be liable for any loss of theft of personal property and does hereby fully and forever release and discharge The Shooting Academy Listowel from any and all claims, demands, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated, resulting from or arising out of the patron's use or intended use of The Shooting Academy Listowel facilities and equipment.
4. The patron hereby covenants and agrees to indemnify and save harmless The Shooting Academy Listowel from and against any and all liabilities, losses, costs (including, without limitation, legal fees on a solicitor and his own client basis), actions, suits, claims, demands or damages of any nature whatsoever brought or instituted against the patron based on or arising out of the negligent actions or omissions of the patron while attending at The Shooting Academy Listowel.
5. If any one or more of the warranties of the patron herein made shall cease to be true at any time during this agreement, The Shooting Academy Listowel, at its discretion, terminate this agreement forthwith.
6. Should the patron discontinue the membership, for any reason, whatsoever, any monies paid toward payment of the membership shall be forfeited and no part of such monies shall be refunded by The Shooting Academy Listowel.
7. The patron agrees to keep and obey all rules and regulations now in force or in the future prescribed by The Shooting Academy Listowel. If the patron fails to comply with any of the above, the patrons membership may be terminated without refund, or the usage rights of the patron may be suspended for an amount of time determined by The Shooting Academy Listowel, at the sole and absolute discretion of The Shooting Academy Listowel. The Shooting Academy Listowel reserves the further right to suspend or terminate the patrons membership or any part thereof, for any conduct found to be immoral, fraudulent or improper at the sole and absolute discretion of The Shooting Academy Listowel.
8. The patron acknowledges the ability to access The Shooting Academy Listowel range facility outside of regular, staffed hours and the corresponding issuance of an access card to the patron, are privileges of the membership which may be granted, revoked and reinstated at any time at the sole discretion of The Shooting Academy Listowel.
9. Severability – If any portion of this agreement is held to be invalid, the remainder of this agreement shall remain in force and effect.
10. This agreement replaces and supersedes any previous membership agreement between the patron and The Shooting Academy Listowel bearing an earlier date.

The patron acknowledges that they have carefully read and fully understand the contents of this agreement, and that this agreement contains all of the terms between the parties, and that no further representations, covenants, or warranties other than those found herein have been made by The Shooting Academy Listowel.
