

WOW Cyclothon 2018

Terms and Conditions

I, as a participator (hereafter “Participant”) of the WOW cyclothon bicycle competition around Iceland in 2018 (hereafter “Competition”), hereby confirm and agree to the following:

- The Participant has read and fully understands the race rules and regulations introduced and available on the Competition’s website wowcyclothon.is.
- The Participant acknowledges that the Competition is not held by and is not the responsibility of WOW air, the Icelandic airline. The organizer of the Competition is the WOW Sport Foundation.
- The Participant is aware of the dangers that can arise during the Competition and takes full responsibility for accidents that can happen during the Competition, such as damage to items, bodily harm and death.
- The Participant is properly trained and physically and mentally prepared to complete the full distance in the Competition.
- If the Participant is aware of any disease or any other health-related issues that might increase the risk of bodily harm or injury during the Competition, he must first consult with a professional healthcare provider before registering for the Competition. The Participant shall not register for the Competition against the advice of a healthcare provider;
- The Participant agrees to hold the organizer, all staff, or others involved with the organizing of the Competition harmless and indemnify them from any responsibility for bodily harm, death, damage to items or equipment or anything else he/she considers harmful or a loss that happens during the Competition;
- The Participant will follow the rules of the Competition and all instructions/orders from the organizer of the Competition or any Competition staff.
- As permitted by law, the Competition’s staff and organizers are not responsible for any bodily harm or any other harm, loss or damage that can happen to the Participant during the competition or because of the Competition in any way.
- As permitted by law, the Competition’s staff and organizers are not responsible for damages or destruction of any items or equipment that occur during or because of the Competition.
- If the Participant has an accident, is harmed in any way or experiences damage to items he/she will report it to the staff/organizers of the Competition as soon as possible.
- The Participant in the Competition takes complete responsibility for themselves regarding all risks of accidents, harm and damage that may occur during or in relation to the Competition. It is also the Participant’s responsibility to ensure that the condition of his/her gear is in accordance with the Competition’s rules and safety regulation.
- The Participant commits to follow all rules and regulations of the Competition which are published on the website www.wowcyclothon.is, and to follow all instructions by the staff/organizers regarding the Competition.
- If the Participant does not comply with the rules of the Competition or instructions or orders from the organizer or other staff, the organizer reserves the right to unilaterally disqualify the Participant.
- The Participant allows photos, videos and other marketing material to be taken during the Competition and that all material may be used to promote future competitions as well as published in articles related to cycling.
- The Participant acknowledges that the results of the Competition will be publicly published. The results may include the name of the Participant, his/her nationality, age and race time.

- The Participant is aware that team cars will have to have GPS trackers installed and the Competition's staff is allowed to use and process data from these trackers. An example of use is to publish the car's live location online during the race so that the audience can track the progress of the team or individual.
- Participant driving a team car or other vehicle in the Competition shall at all times be physically and mentally qualified and capable to operate that car or vehicle.
- Driving and the condition of the car or any other vehicle used during the race shall at all times be in accordance with the laws and regulations of Iceland.
- It is entirely the responsibility of the Participant to have adequate insurance for possible damages relating to the Competition. Therefore, the Participant is highly encouraged to make sure that he or she has adequate insurance in relation to the Competition. In that regard, the Participant should note that the Competition is a sporting event which he or she has registered for at his or her own risk. In addition, Participants should check their credit card insurance with regard to Icelandic car rentals.
- If the Participant is unable to participate in the Competition, the entry fee and any additional payments will not be refunded.
- The Organizer is not liable for any costs incurred by the Participant if the Competition is cancelled due to force majeure.
- The validity, construction, interpretation and effect of these terms and conditions shall be exclusively governed and determined by and in accordance with the laws of Iceland.
- Any action or suit arising under these terms and conditions or against the Organizer in relation to the Competition is subject to the exclusive jurisdiction of the District Court of Reykjavik, Iceland.
