



Temple Akiba Early Childhood Center

Tuition Agreement 2018-2019 School Year

_____ (“Child”) is hereby enrolling in the Temple Akiba Early Childhood Center (“TA ECC”) for the 2018-2019 school year, subject to the terms and conditions of this Tuition Agreement (“Agreement”). This Agreement is entered into between Temple Akiba (“TA”) and the parent(s) and/or guardian(s) who have signed below (collectively “Parent”). **By initialing in the box at each paragraph and signing this Agreement below,** Parent agrees to the terms and conditions set forth in this Agreement.

To complete enrollment, Parent must complete and sign this Agreement and return it to Temple Akiba ECC by February 13, 2018 along with a \$100 non-refundable registration fee.

1. Parent agrees to pay all fees for the 2018-2019 school year on a monthly basis from September 1, 2018 – June 1, 2019 in a maximum of ten equal payments as stated in the terms set forth below.

2. Parent acknowledges and agrees that the full tuition amount indicated above for the 2018-2019 school year will be due and payable unless enrollment is withdrawn by written notice to the Director of the TA ECC prior to Friday, June 8, 2018. If notice of a withdrawal is received by TA prior to June 8, 2018, the Child will not be enrolled in the ECC and Parent shall not be liable for any additional tuition or fees, however the \$100 registration fee shall not be refunded.

3. Parent agrees to pay all tuition and fees when due each month, and to comply in full with the terms and conditions of this Agreement. In the event any payment due under this Agreement is not made by the 10th of each month, a late fee of \$25 will be added to the monthly payment.

4. Parent agrees to inform Director in writing if early morning care (8:00 – 8:45 am @ \$50 per month) will be needed for Child. Total tuition amount will be amended accordingly.

5. Parent agrees to pay a \$200 one-time fee for all new students or \$25 annual fee for all returning students to cover emergency supplies and scrapbooking supplies.

6. Parent acknowledges that TA reserves the right, at its sole discretion, to not permanently enroll or to terminate the enrollment of any child whose needs we cannot meet and/or because of material failure by Parent or Child to comply with the policies and procedures of the ECC. In the event that such action by TA is necessary, Parent understands and agrees that no refund shall be owed for any tuition and fees previously paid.

7. Parent agrees to complete and return a current Registration Packet by **Friday, August 24, 2018**, prior to the start of the school year and that Child may not attend school until the completed Registration Packet is received by TA. A current Registration Packet must be completed and returned by Parent to ECC for the upcoming school year even if the Child is a returning student.

8. Parent hereby gives full consent and permission for Child to participate in all activities offered by the ECC to its students. Parent also understands and acknowledges that in addition to the tuition, there may be other costs (such as field trips or special activities) which Child may incur and for which Parent will be responsible. Parent hereby waives, discharges, and releases TA ECC and each of their respective officers, agents, and employees from all claims of liability for any accident or injury incurred by Child during any school activity, except for any accident or injury caused by the willful malfeasance of TA or its agents.

9. Any and all claims arising out of, or relating to this Agreement or its performance, breach, or interpretation, including any claim for any equitable remedy, shall be finally resolved by binding arbitration in accordance with the Commercial Arbitration Rules of the American Arbitration Association. The arbitration shall be held in Los Angeles, California, before a single arbitrator, who shall be a member of the State Bar of California, chosen under the administration of the American Arbitration Association. The arbitrator shall apply California law in reaching its decisions as if sitting as a judge in a court of law.

10. No waiver of any obligation under this Agreement shall be valid unless in writing and signed by the Director of TA ECC.

11. Parent understands, represents and warrants that: (i) Parent is the parent(s) and/or legal guardian of Child; (ii) this contract is a binding legal document, jointly and severally enforceable against each Parent who has signed below; and (iii) Parent is authorized to enter into this Agreement.
