This Agreement is made between Green Pastures Christian Campground Inc. hereinafter referred to as LESSOR of property at 1936 US Highway 67, Meredosia, IL and _____ of _____

hereinafter referred to as the LESSEE. The Lessor is an independent, interdenominational, not for profit, 501(c)3 religious organization committed to providing a positive environment for young people to develop their relationships with Christ and other Christians. These retreat facilities are supported by volunteer efforts and contributions of individuals, and community organizations. It is mutually agree that every courtesy will be extended between the parties involved, and every effort will be made to comply with this agreement.

TERMS OF LEASE AGREEMENT

1. Lessor agrees to furnish Green Pastures Retreat Center for the purpose of holding a retreat, camp, conference, reunion or any church related activities for the dates listed below. **Extra fees may apply for groups wishing to set up or tear down outside the specified lease period.**
2. Lessee shall not assign or sublet the premises or any part thereof without written consent of Lessor.
3. Lessee shall comply with all lawful requirements of the Board of Health, Police, Fire Departments and all authorized government.
4. **Firearms, fireworks and alcoholic beverages are prohibited** on Green Pastures property.
5. Lessee agrees to hold Green Pastures Retreat Center free from all liability in the operation of their retreat.
6. **A \$100 deposit is to be received with the signed contract.** Deposit will be refunded if cancellation is received in writing thirty (30) days prior to lease date. Final payment will be made upon completion of retreat when proper amount is determined. (See rates on page 2)
7. Lessee agrees to compensate lessor for any damage to property or any broken, lost or stolen items; and to leave the buildings and grounds reasonably clean. A \$100 cleaning fee will be applied if the minimum standard is not met. **Groups are encouraged and expected to help keep the facility in good shape.**
