# The Pancake Parlour – Winter Parlour Terms and Conditions

## Entrants:

Entry to the Promotion is open to Victorian residents who are aged 16 years or above and are currently Lovely Rewards members at The Pancake Parlour. Members under the age of 18 who wish to sign up require parental consent. Anybody aged under 16 does not need to register, however can participate in the promotion as long as they are accompanied by one (1) Lovely Rewards member at time of Winter Parlour offer redemption.

# **Promotion Period:**

Starts: 10:01am AEDST 03/06/2022 Ends: 11:59pm AEDST 31/08/2022

## **Promotion:**

Participants are eligible to redeem offers determined by The Pancake Parlour at any time, at the Winter Parlour price to temperature conversion represented by the temperature trigger points on the website – <u>www.winterparlour.com.au/live-temp-update</u>

## Location of Entry

Customers will need to a) become a Lovely Rewards member by registering to the Winter Parlour promotion via downloading The Pancake Parlour Rewards app, or; b) already have an existing Lovely Rewards account to be eligible for the Winter Parlour promotion.

Once registered, members will receive weekly email communications that contains the week's offer via email, social media or the app.

## How to redeem

The Winter Parlour offer will be redeemable by presenting the member barcode on The Pancake Parlour app in-restaurant at counter for scanning.

### Temperature to price conversion

The temperature to price conversion is a representation of the live Melbourne temperature according to the 'Melbourne – Melbourne Airport' location on the Bureau of Meteorology website (www.bom.gov.au) and determines the Winter Parlour price at the time of payment. The final price is to be determined after the 'Refresh' button has been triggered by the customer or staff member at the time of payment - www.winterparlour.com.au/live-temp-update. There are four temperature brackets that will determine the price of the offer:

-	Under 5ºC	\$5
-	5.1ºC to 10ºC	\$10
-	10.1ºC to 15ºC	\$15
-	15ºC+	Normal RRP price

Should the price conversion be **above** the menu price of the product, the customer will only be charged the full menu price. If the price conversion is zero or below, the customer will receive the offer at \$5. The customer will not receive a credit if the price conversion is negative. Low-gluten and vegan options are available as part of the promotion. Gluten free options will be available at the price in the bracket.

#### **Details of offer**

On Friday of each week during the promotional period, customers will be advised of the Winter Parlour flavour of the week via The Pancake Parlour's Winter Parlour website (<u>www.winterparlour.com.au</u>), and <u>Facebook</u>, and <u>Instagram</u> networks, as well as email.

#### Activation of offer

The Winter Parlour offer of the week will be valid between 9am Friday and midnight the following Thursday, and is redeemable at the Winter Parlour price to temperature conversion, which is determined at the time of payment by The Pancake Parlour team member according to the Melbourne Airport temperature indicated on the Winter Parlour website at the time.

#### Location of offer redemption

The Winter Parlour offer is valid dine in only at ANY Melbourne The Pancake Parlour restaurant. There is no restriction to which restaurant the offer can be redeemed from.

Users of The Pancake Parlour app can process their redemption via the app by simply selecting the item on Winter Parlour special for the week from the Winter Parlour menu category. The price on the item will be updated on the app in real time. If the app does not show the correct temperature at time of purchase, close the app and re-open to refresh or ask a team member for further assistance.

#### **Maximum Number of Entries:**

Entrants can only register once. Only one Lovely Rewards account can be used per person, however members can redeem the offer for an additional three (3) persons aged under 16 who are present at time of purchase. If no person aged under 16 is present at time of purchase, only one valid sweet pancake choice can be redeemed per member account, per day.

## Other offers during promotional period

- After every 3 visits during Winter (June 1 to August 31), members will be rewarded with a *free tea or coffee with meal purchase*. Vouchers will be redeemable via the bonus offers section of the member's app
  - a. Only one visit can be accumulated per day, despite multiple transactions
- 2. **Most visits for the Winter** will be rewarded with a year's worth of Pancakes. The Pancake Parlour marketing team will determine the winner at end of campaign
  - a. In the event of a tie, the member with the highest spend during the period will be deemed the winner
  - b. Member must purchase minimum one (1) food item while dining in to qualify the visit. Item does not have to be a Winter Parlour promotion item
  - c. Winner will be announced on September 2, 2022
  - d. A year's worth of pancakes is valued at \$1,200. \$100 voucher will be coordinated to the winning member each month over a 12-month period.

## **Terms of Entry**

1. These terms must be read together with the Schedule for this Promotion. The Schedule defines certain terminology used in these Terms of Entry. Participation in the Promotion constitutes acceptance of these Terms of Entry. To the extent of any inconsistency between the Schedule and these terms, the Schedule prevails.
