Trade Wars or Trade Winds: Which Way is the Wind Blowing CR3

What do trade tensions between the United States and China, the two largest trade partners of Asia-Pacific economies, mean for the Asia-Pacific Region? Despite the potential shock and disruptions of a trade war between the United States and China, the economies in the vast Asia Pacific region are projected to keep growing and some may even benefit from a trade war. The United States and Europe remain invaluable economic partners for the region. Value added to raw and other goods in Asia-Pacific economies makes its way to the United States either directly or indirectly via China underscoring the interdependence of these two economic powerhouses. The potential impact of a protracted trade dispute is clear if it continues to expand and escalate. Many countries in the region are pushed and pulled by traditional alliances, commercial priorities and future interests as the world's two biggest economies go head to head in a trade war. With this backdrop in mind, the panel will explore the current trade environment, and the impact trade disputes will have on regional and global economic growth.

11:15 - 12:30 Plenary Session Panel II The Future of Security and Prosperity of Asia Pacific CR3

Geopolitical uncertainty, including established and emerging power rivalries, challenges to multilateralism, the growing influence of non-state actors and the implications of unprecedented technological advances, has created challenges to the Post WWII economic and security alliances and architecture in the Asia-Pacific region. These challenges manifest themselves in a number of ways in the Asia-Pacific and are at the top of domestic and foreign policy agendas— along with the future of the WTO, resolution of the East and South China Sea disputes and containment of North Korea's nuclear ambitions. Asia-Pacific nations share the goal of preserving peace and prosperity, but have different ideas about how to achieve this goal. How can governments in the region and other actors create a more effective role in strengthening cooperation and reducing regional tensions? What are the prospects for forming a regional security architecture that can manage issues such as economic growth and development, maritime territorial disputes, strategic stability, and nontraditional security challenges? The Panel will explore the impact of these challenges to the security and prosperity in the Asia-Pacific region.

Harnessing Technology to Enhance Research and Engage Policymakers CRA

The popularization of new media has created a massive untapped pool of resources for knowledge to be shared with a new and wider audience. The Coming Food and Water Crisis CRF

Food and water insecurity are not just a future problem, but rather are serious crises that our world is presently facing. In 2016, The Food and Agriculture Organization of the United Nations reported a total of 815 million chronically undernourished people in the world. In addition, the World Health Organization reported in 2015 that there was a total of 2.1 billion people who lacked access to safely managed drinking water. There are many contributing factors to food and water insecurity, such as climate change, poverty, gender inequality, and macro-economic trade policies— each of which are complex issues that require comprehensive research. This research gap can and should be filled by think tanks, that can then take a prominent role in addressing these causes of food and water insecurity. Think tanks have a unique position in food and water security research and can address interdisciplinary and trans-boundary concerns, facilitating critical knowledge exchange, and generating overall issue awareness. Despite the clear intersect between these two crises, institutional and disciplinary silos inhibit the development of creative policies and programs to address the problem. A panel of scholars will examine the coming crisis and suggest some ways of addressing it.

Economic Growth, Integration and Alliances in the Asia Pacific CR3

The Asia-Pacific region is one of the world's growth centers. The Summit provides an opportunity for the region to take stock of the achievements made in regional integration and cooperation, as well as a chance to look ahead and consider what needs to be done to achieve the vision of a unified and seamless economic community in the Asia-Pacific Region. The realization of a stable, peaceful and prosperous region is a priority for many countries in the region. To achieve this, it is essential that countries commit to a peaceful and stable regional community underpinned by rules that comply with international law and a free, open regional economy that builds on the various regional organizations and cooperative frameworks with countries in the region, as well as Europe and the US. There has been some success with regional integration in a number of sectors including tourism, infrastructure and consumer protection, in an effort to foster inclusive and sustainable growth across the region. The most prominent overarching risks to growth at this point are the possibility of a more rapid monetary policy contraction in advanced economies; the rapid rise in private-sector debt; and the broadening of trade restrictions globally, coupled with limited progress in regional trade agreements. Consciously or inadvertently, the new world order is taking place. Alliances are shifting, conflict and mass migration of people is continuing, and sustained economic growth and development is remaining elusive. The 2019 Asia-Pacific Think Tank Summit is taking place at a truly extraordinary historical moment in world politics.
