DID YOU KNOW? IF YOU ARE OVER THE AGE OF 70 ½, YOU CAN MAKE A DIRECT GIFT FROM YOUR IRA TO FELLOWSHIP WHICH COUNTS TOWARD FULFILLING YOUR REQUIRED MINIMUM DISTRIBUTION AND REDUCES YOUR TAX LIABILITY.



CORPORATE GIFTS

- Giving on behalf of your organization or business
- Corporate giving programs that reward employee giving to nonprofits by doubling or tripling an employee's donation.
- Donating materials, goods, or services from your business - i.e. HVAC, landscaping, etc.

Why a campaign?

Fellowship has experienced a season of tremendous growth in both size and ministry over the past several years. We have seen increased numbers in every area of our church body, especially our young families.
