• MCI Framingham civil commitments must have coinciding bail status – the commitment is eligible for the First Step Program (attachment). If bail is met, the commitment will be eligible for transfer to a different facility.

First Step Program

First Step is a residential substance abuse treatment program located at MCI Framingham. This program provides substance abuse treatment services to women who have been sentenced, are awaiting trial, and who have been civilly committed (with a dual criminal status) pursuant to Massachusetts General Laws. c. 123 section 35, or have been identified as needing immediate detoxification and treatment. The treatment component consists of a 20 day schedule of classes on substance abuse education, relapse prevention, parenting and interpersonal skill acquisition. The major emphasis of this program is linking participants to aftercare services both in the facility and post-release in the community.

- Public ATS public programs are offered as an alternative only when the sec 35 designated programs are projected to be at capacity. Referrals will have access to the same levels of care (detox / step down) and aftercare programs that are offered by other 35 programs. Court notification forms are sent to comply with the court rules. Designated public programs are classified as voluntary and therefore an individual may request discharge against medical or clinical advice.
- Youth Stabilization programs (CASTLE MYR) are also classified as voluntary public programs. ATS and Youth Stabilization bed numbers represent overall program capacity for both public and sec 35 admissions.
- Central Intake makes the determination of what facility is available for a commitment based on clinical appropriateness and bed availability.
