## Fees & More

### FLAT RATE - \$180/horse

Includes all AQHA classes, AQHA Fees & Office Charge. Multiple riders - multiple classes. Does **NOT** include Stall (s), NSBA classes, shavings, RV or Trail Warm ups.

Entry Fee: \$16/judge/class - OPEN

All other divisions - \$13.00/judge/class

Office Charge - \$5.00 per horse/judge

Trail Warm Up: \$10.00/horse

AQHA Drug & Processing Fee - \$6.00/horse/show

Small Fry - 9 years & under. \$7.50/class or \$20.00/judge all day fee. (Per Judge)

**Walk/trot Classes:** \$10/judge/class - These are AQHA approved classes. Papers & cards required. NOTE: Per rules - If a horse-rider combination was entered into a Level 1 walk-trot class, that horse-rider combination cannot show in the corresponding loping/cantering class at that show. However, that combination can switch back and forth between the different shows.

**Grounds Fee:** \$15.00/day/horse for those without a stall

NSBA Dual/Approved- \$10.00 per class - single judged.
