- ### Nrha Show Requirements
1. Owner must have a current membership (General is Min. level)
  2. Rider Must have one of the following indicated on membership card.
    - NON PRO
    - YOUTH
    - PROFESSIONAL
  3. Novice Horse Level 1- Horse can not have earnings over \$5000.00
  4. Novice Horse Level 2 – Horse can not have earnings over \$25,000.00
  5. Rookie Lvl 1- Riders can not have earned more than \$500.00 lifetime earnings/200 yth points excludes SS yth points and must have a **Non Pro** status.
  6. Rookie Lvl 2 – Riders can not have earned more than \$1500.00 lifetime earnings/300 youth points exclude SS Yth and must have a membership of **Non Pro** Status
  7. Ltd Non Pro – Riders can not have earned more than **\$10,000.00 lifetime earnings**. Must have **NON PRO** Membership
  8. Int. Non Pro – Rider can not have earned more than **\$5000.00 in 2018**. Must have **NON PRO** membership
  9. Rookie Pro – Open to Professional riders only, no youth or Non Pros. Riders can not have earned more than **\$5,000.00 Life time earnings**. Must have **PROFESSIONAL** membership
  10. Ltd Open – Riders can not have earned more than **\$5000.00 in 2018** Must Have **PROFESSIONAL** for membership
  11. Int. Open – Riders can not have earned more than **\$7,500.00 in 2018**. Must Have **PROFESSIONAL** for membership
  12. There are few limitations, a rider can only fall back one level each year, so if you and not sure of your eligibility, you can look it up on the NRHA website. It is the responsibility of the rider to know what level they can show in.

Those classes running concurrently will pay **ONLY ONE** judges fee.
