## The Finer Points

**\*\*FLAT RATE - \$175/horse** - includes all AQHA classes, AQHA Fees, IQHA Fees & Office Charge. Multiple riders - multiple classes.

Does **NOT** include stall, Futurity classes, NSBA classes, shavings, camping or Trail Warm ups.

**Entry Fee:** \$13.00 - per judge/class

**Office Charge** - \$10.00 per horse - one time charge

**Trail Warm Up:** \$10.00 per horse - one time charge

**AQHA Drug & Processing Fee** - \$6.00/horse/show - 4 shows

**IQHA Fee:** \$0.50/Judge/Class

**NSBA** - \$10.00 per class - single judged each **OR** \$35 flat rate. Single judged.

**Small Fry** - 9 years & under. \$7.50/class/judge or \$25.00 all day fee. (Per Judge)

**Walk/trot Classes:** \$10/judge/class - These are AQHA approved classes.

**NSBA Futurity Classes:** \$50 each/55% of entry fee jackpotted. Must have 3 entries per class. Certificate of eligibility required.

**Grounds Fee:** \$25.00/day/horse for those without a stall

**DOGS** - ALL dogs must be on leashes.

### Futurity Entries

Start with Connie, double check your paperwork & IF you are eligible to enter into the corresponding AQHA class, see the AQHA office. You will NOT be charged for the entry fee, IQ fee or Office charge.

You ONLY pay the AQHA processing fee.
