The Finer Details

****FLAT RATE - \$200/horse** – includes all AQHA classes & Office Charge. Multiple riders – multiple classes.

Does **NOT** include stall, AQHA Processing fees, Futurity classes, NSBA classes, shavings, camping or Trail Warm ups.

Entry Fee: \$12.00 – per judge/class

Office Charge - \$8.00 per horse/judge – 4 judges

Trail Warm Up: \$10.00 per horse

AQHA Processing Fee - \$8.00/horse/show – 4 shows

NSBA - \$10.00 per class – single judged **OR** \$35 show

Small Fry (11 & under) & Leadline (6 & under) – \$5.00/class/judge – If horse only showing these classes, will not be charged an

office fee or AQHA processing fee.

Classes shown **BOXED** will be run concurrently.

Reserved ONLINE ONLY beginning February 27, 2021 at www.AnEquineProduction.com

Stalls: \$135/stall reserved with credit card ONLY by August 12, 2021. ALL stalls reserved after August 13th - \$150/stall.

(Deadline August 12th to scale/cancel & price increase.) Stall credit cards will be processed on August 13th

Those wishing to be stalled together, must be reserved together. No stall refunds after August 12th. ALL stalls & shavings must be RESERVED online. The card you use to reserve will NOT be charged unless you do not provide another form of payment by August 12. Trainers you can find the trainer's tab sheet on our website at any point & turn it into the stall office.

Horses may not arrive prior to 8:00 am on Thursday, September 2.
