North American Water Office (NAWO) Environmental Justice staff has been following Northern Metals' nasty business practices for nine years and counting. Tracking the permitting of their activities and providing public testimony before the Minnesota Pollution Control Agency, and Community Organizing are our primary actions. NAWO joined up with the North Minneapolis Community (Community Members for Environmental Justice) to demand clean air and water for all Minnesotans.

Northern Metals has a habit of lying to Regulators and the Public about how the air quality emissions from their facility are monitored and reported. A whistleblower employee noticed changes to the monitoring records that had documented air quality violations that were subsequently eliminated from those same records.

The North Minneapolis Community and their supporters created enough pressure on the Minnesota Pollution Control Agency and forced Northern Metals to relocate their primary operation to Becker County, Minnesota out of the North Minneapolis Community. But, the real problem, the ASR or auto shredder residue, AKA: FLUFF is still piled twenty feet high and higher on their North Minneapolis site.

"What is FLUFF" you ask?

We looked up the science of what FLUFF contains and it's sorta ghastly. Each automobile yields 350 pounds of ASR after the metals are stripped out. Of that 350 pounds, twenty pounds are poly-vinyl chloride (PVC) 50% chlorine by weight. Why should you care?? Burning PVC gives us DIOXIN in all its forms, furans, and polychlorinated biphenyl (PCB). These are all fancy words for carcinogens.

Wait, there's more. Heavy metals like mercury are emitted at the rate of three pounds a year. Just for comparison one gram of mercury can contaminate a 20 acre lake.

Other heavy metals are emitted, but testing for arsenic, beryllium, cadmium, hexavalent chromium, lead, manganese and nickel was eliminated from routine monitoring every 60 months. Northern Metals argues that its annual monitoring plan is adequate for the amount of these emissions released by their operations. Northern Metals, however did ask for increased allowances for these emissions in their 2012 permit renewal. FLUFF contains all these previously listed listed toxic heavy metals and carcinogens. Here's the kicker... FLUFF spontaneously combusts if the stacks of FLUFF materials are above 20 feet. On April 21, 2021 such a blaze occurred at the North Minneapolis site 2800 North Pacific Street.

The piles of FLUFF were twice as high as they should have been, again.

Northern Metals' business function is to perform a service modern society *really* needs. However the profitability of such a service decreases with collection, transportation, record keeping, monitoring, required pollution control equipment, and reporting to government agencies. Northern Metals has multiple falsifying documents infractions, and multiple fires from FLUFF piles not in compliance exceeding 20 feet at both Becker County and North Minneapolis sites.

Northern Metals is not the only corporate polluter in North Minneapolis. Cemstone, Aggregate Industries, GAF, Precision Associates, Coremark Metals, and Estes Cremation to name a few corporations that are located in the Interstate-94 corridor along the Mississippi River in North Minneapolis. While each industry may be permitted to emit a cocktail of substances into the air at a level Regulators have licensed as acceptable, adding up the cumulative levels and the air quality plummets Northside asthmatics gasp and cancer patients rise.

Two additional contributing sources include transportation particulate emissions from a major Interstate 94 Highway, and ionization of those respirable particles by the high voltage transmission lines in the corridor that discharge corona creating charged particles making the particles stick to mucous linings of the throat and lungs. No wonder Community Members for Environmental Justice are fed up and getting organized!


