## Liability Release and Waiver Agreement for Imprint Tours

Accidents can happen anywhere. However, traveling anywhere outside the United States, even traveling with Imprint Tours can involve risks and hazards that are far greater than usual. Although Imprint Tours can use its experience and knowledge to help make your vacation fun and safe, things can go wrong. By signing this document, you agree to assume the risks of traveling abroad, however great or slight they may be. Because of where and how you will travel, and the fact you sometimes will travel by bus on fast highways, busy, narrow or contested streets, and because of the forces of nature, you understand that accidents, illness or other unforeseen mishaps can occur. You understand that sometimes accident or illness or inconveniences can occur in remote places where there is no ready assistance or medical care. You also understand and agree that although Imprint Tours and all of its employees, agents, officers, and representatives (hereafter referred to as "us" and "we") carry general liability insurance, you are not insured under our insurance if someone has a claim against you; nor do we carry liability insurance that pertains to accidents, injuries or events caused by other people. You also understand that we do not provide any medical, health or related services on our tours, so you agree to make sure your own health needs, and the needs of your spouse and family, are taken care of by yourselves.

In return for the consideration of participating in a tour with Imprint Tours and in consideration of the money you have paid, and our agreements with you, you also agree to waive and release any claim you, your family members or spouse could assert against us. We will do our best to make your travel safe, pleasurable and fun. Nevertheless, you agree that if something goes wrong, or if you have any disputes with us, currently or in the future, you have waived any claims you could have brought against us. As you know, part of the fun, and part of the risk, of traveling in foreign countries is that food and water and lodging and local customs can be very different from what you are used to. Thus, your waiver of claims includes any disputes you may have about tour accommodation, food service or quality, transportation, sightseeing, or your itinerary.

You also agree that among the events we want to avoid, but that you could encounter, are strikes, theft, political instability, poor roads or public services or transportation, actions by police, customs, or local law officials, inclement weather, civil unrest . . . even incidents of war, sabotage or terrorism; and you also specifically agree that you have waived, and cannot ever bring claims against us for anything or any kind of property or personal damages or injuries or even death based on or arising out of those events or situations. Because it is impossible to foresee everything that can possibly go wrong, even that which is currently unknowable, unanticipated or unforeseeable, we ask, and you agree that, as to us, you have released and waived even claims based on or arising out of that which is unknown, unanticipated or unforeseeable.

You also understand and agree that if someone should assert a claim or demand or cause of action against you for something that arises out of or relates to this Tour, you have agreed that you cannot, in turn, seek any contribution or indemnity or defense from us.

Although we want everyone to have a good time, it sometimes happens that someone participating in a Tour can misbehave or do things that are incompatible with the safety, comfort or convenience of other members of the Tour. You agree that in those circumstances we have the exclusive right and discretion, to expel someone, or even you, from a tour at any time without any claims or complaints by you against us.

## Imprint Tours Terms and Conditions

This document outlines what Imprint Tours agrees to provide when you sign up for a tour, and what you agree to do in return.

**Included in the price of each tour:** Sightseeing tours by local guides, including admissions to sights seen as a group; meals as listed in tour itinerary; accommodations each night of the tour; all transportation required for group activities from the first hotel to the last hotel of the tour (transportation for optional group activities and independent travel during the tour is not included); all guide, local guide, driver, and hotel tips.

**Prices do not include airfare to and from the tour.**

**Tour payments:** To reserve a seat on an Imprint Tour you must provide a deposit of \$400 per person and a signed Registration Form, thereby agreeing to these Terms and Conditions (Imprint Tours 137 Willowstone Ct Estes Park CO 80517). We do not accept credit cards. Your non-refundable, final tour payment will be due **90 days** before departure. Tours which include internal flights arranged by Imprint will require full payment **120 days** before departure. Missing the final payment deadline may result in your being removed from the tour. If you sign up for a tour within 90 or 120 (see above) days of the tour departure the non-refundable, full payment will be required before we can confirm you on the tour.

**Early payment discount:** An Early Payment Discount (EPD) is awarded for full payment 8 months prior to tour commencement (final date of availability is set and posted for each eligible tour; not available on all tours; discount amount varies). \$600 of the early final payment is non-refundable. \$1000 of the early final payment is nonrefundable if no deposit has been paid. In the event of cancellation, the remainder of the early final payment is refundable until 90 or 120 days before departure (see Tour Payments above), after which time 100% of funds paid are nonrefundable.

**Cancellations and deposit refunds:** Deposits for all tours are 100% refundable for 30 days upon receipt, **and after that time they are not refundable for any reason and will be forfeited if you cancel your tour reservation.** All cancellations must be sent to Imprint Tours in writing via e-mail to [info@imprinttours.com](mailto:info@imprinttours.com) or via postal mail to Imprint Tours 137 Willowstone Ct Estes Park CO 80517, and will be effective on the date received.

**NSF Check Fees:** If a payment is returned due to non-sufficient funds (NSF), Imprint Tours will assess a \$45 fee per occurrence. The fee(s) will be added

to the applicable tour balance, and be required to be paid in full prior to your tour departure.

**Solo Travelers and Single Accommodations:** Single accommodations can be requested by paying a single supplement fee; these are limited and based on availability. For those willing to share, Imprint Tours will attempt to arrange a same-gender roommate, and if so, the Single Supplement is waived. If a roommate can not be found, tour participants will be required to pay the Single Supplement.

**Travel Insurance:** Imprint Tours encourages all tour participants to purchase separate travel insurance to cover possible additional costs (airline tickets, loss of luggage, trip delay, medical evacuation, etc.) and/or trip cancellations. Affordable coverage, provided by Travelex, is available through Imprint Tours.

**You'll want to pack light:** Each tour participant is strongly encouraged to bring just one airline-carry-on-size bag of approximately 22"x14"x 9", and a small day bag. Please note you will always carry your own bags, which may include carrying up many steep stairs, walking up to 10 minutes to the hotel, and loading/unloading from many types of transportation.

**Imprint Tours are physically demanding:** Our tours are physically demanding. To enjoy the experience, you must be in good shape. The most active days may average 5-6 miles of walking (often over uneven surfaces and including lots of climbing/steps), lots of standing while listening to your guide during group sightseeing, and stair-climbing while carrying your own bag up to your hotel room.

**Non-smoking tour:** Smokers may smoke only outdoors and downwind from the group — never in hotel rooms or during group activities or meals.

**Children on tour:** Children under age 18 must room with and be accompanied on the tour by a parent or guardian. A Child Transport waiver must be signed by parent or guardian.

**Tour itineraries are subject to change:** Travel is full of surprises and we need to be flexible enough to take advantage of whatever comes along so that we may provide you with the best possible tour. Uncompleted portions of the tour itinerary are not cause for refund.

**Transportation Liability:** Imprint Tours acts only as an agent for the transportation vendor with respect to transportation. Although we exercise every care possible, we can assume no liability for injury, damage, delay, loss, accident or irregularity in connection with the services of any airplane, boat, motor-coach, minibus, train, or other conveyance, public or private, used in carrying out the arrangements of the tour. We cannot accept responsibility for losses or additional expenses due to delay or changes in transportation services due to sickness, weather, strike, war, quarantine, acts of God or other causes beyond our control. All such losses and expenses will have to be borne by the passenger, as tour rates provide for arrangements only for the time stated.

Additionally, Imprint Tours does not accept liability for any airline carrier's cancellation penalty or change fee incurred by the purchase of non-refundable tickets to or from the tour.

**Accommodation Liability:** Imprint Tours acts only as an agent for hotels with respect to accommodations. Although we exercise every care possible, we can assume no liability for injury, damage, loss, accident, or irregularity in connection with the services of any tour hotel.

**Misprints:** Imprint Tours reserves the right to amend typos and misprints in pricing and other trip information.

**Participation:** Although we want everyone to have a good time, it sometimes happens that someone participating in a tour can misbehave or do things that are incompatible with the safety, comfort or convenience of other members of the tour. You agree that in those circumstances we have the exclusive right and discretion, to expel someone, or even you, from a tour at any time, without any claims or complaints by you against us. Moreover, we reserve the right to decline to accept any person as a participant in our tours.

**Assumed Risk:** Tour participants intentionally accept the many risks inherent in international travel and are required to sign and return, prior to their tour start date, a Liability Release agreement.

**Disabilities:** Any pre-existing physical, mental, or emotional disability that may require attention or treatment must be reported in writing prior to the beginning of a tour. All tour participants are required to complete, sign and return, prior to their tour start date, a Medical Form.

**Tours cancelled by Imprint Tours:** Although unlikely, your tour may be cancelled due to unforeseen circumstances or lack of participation. If we cancel a tour you have reserved, the entire amount you have paid for the applicable tour will be refunded to you within fourteen days after the tour's cancellation, as required by law. Once this occurs, Imprint Tours has no other obligations to tour participants on cancelled trips including any additional costs or fees related to the issuance and/or cancellation of airline tickets or other travel reservations not made by Imprint Tours.
