### Additional Information

Confirmation will be received at time of booking

A minimum of 4 people per tour is required for the tour to proceed.

Vegetarian and vegan option is available, please advise at time of booking if required.

If you need any special assistance during the course of the tour please make this known at the time of booking.

Fitness level required: easy. It is a walking tour, but the walks are easy and on public roads. You are encouraged to wear comfortable shoes.

### Cancellation Policy

Our office must be advised by telephone (1800 667 791) of any cancellation or amendment to a booking as follows: Cancellation Within 7 days – No Refund / 7 to 14 days-50% / Over 14 days full Refund minus booking fees.
