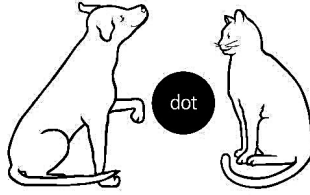

### TERMS & CONDITIONS

1. Dog Dot Cat LLC (Company) will provide a 30 minute mid-day walk for \_\_\_\_\_ between the hours of 11:00am and 4:00pm. Client understands that one or more dog walkers/pet sitters may be used during the duration of this contract. For the convenience of our care providers, Client authorizes Dog Dot Cat LLC to transport their pet by vehicle if need be. All dog walking and other fees can be viewed on our website [dogdotcat.com](http://dogdotcat.com). Dog Dot Cat LLC reserves the right to raise our rates as advertised on our website. 2. Dog Dot Cat LLC's cancellation policy stipulates that all Clients must call, email, or text by 8 PM the night before the scheduled walk to cancel, otherwise you will be charged for that day.
3. An electronic invoice will be sent via e-mail on or about the 1st day of each month for all walks completed the previous month. Client understands that the invoice is due and payable upon receipt. *A \$50 late fee or 10% late fee (whichever is greater) will be assessed for any payments not received within 5 business days.*
4. There is a \$20.00 fee for the Initial Client Meeting with the owners of Dog Dot Cat LLC and Client. There will be a \$20.00 fee if the Client wishes to meet a hired walker. A handling fee of \$25 will be charged on all returned checks. An advance 50% deposit is required on lengthy assignments.
5. In the event Client's dog or cat bites a 3<sup>rd</sup> party, Dog Dot Cat LLC is covered with commercial liability insurance and a dishonesty bond. Dog Dot Cat LLC agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against Dog Dot Cat LLC except those arising from negligence or willful misconduct on the part of Dog Dot Cat LLC. With reciprocal consideration, Client agrees to be responsible for any injuries incurred by Dog Walker/Pet Sitter due to Client's pet (e.g. Pet sitter is bit by Client's pet) or injuries incurred by Pet Sitter due to condition of Client's premises.
6. All pets are to be currently vaccinated. Should Pet Sitter be bitten or otherwise exposed to any disease or ailment received from Client's animal, it will be the Client's responsibility to pay all costs and damages incurred by Pet Sitter.
7. In the event of personal emergency or illness of Pet Sitter, Client authorizes Dog Dot Cat LLC to arrange for another qualified person to fulfill responsibilities as set forth in this contract. Every attempt will be made to notify client regarding such situation.
8. If anyone else has access to your home while the pet-sitting job is being performed, or the pet sitting job is being shared with another person or company, Dog Dot Cat LLC can assume no liability for any damages or losses to your home or pet.
9. Dog Dot Cat LLC is authorized to perform care and services as outlined in this contract. Should medical attention be necessary and specified veterinarian is unavailable, Dog Dot Cat LLC is authorized by signature below to seek emergency veterinary care at Atlas Vet, 1326 H Street N.E (202) 552-8600; Union Vet, 609 2<sup>nd</sup> St. N.E.; Friendship Hospital for Animals (24 hour emergency animal hospital) 4105 Brandywine Street, N.W., Washington, D.C.; or VCA Alexandria Animal Hospital (24 hour emergency animal hospital), 2660 Duke Street, Alexandria VA 22314 (703) 751-2022. Client releases Dog Dot Cat LLC from all liabilities related to transportation, treatment and expense. *Every attempt will be made to notify Client regarding such situation.* However, if Client is not reachable and time is of the essence, Client authorizes Dog Dot Cat LLC to approve medical and/or emergency treatment (excluding euthanasia) to keep pet stable with minimal life support, or as recommended by a veterinarian, up to \$ \_\_\_\_\_. Client agrees to reimburse Dog Dot Cat LLC for any expense incurred, including transportation costs to the vet, for attending to this need. Client also agrees to reimburse Dog Dot Cat LLC for any expenses incurred for home, food, or pet supplies needed and purchased by same.
10. Dog Dot Cat LLC will give the utmost of care in watching both your pet(s) and your home. However, due to the extreme unpredictability of animals, Dog Dot Cat LLC cannot accept responsibility for mishaps of an extraordinary or unusual nature (e.g. furniture damage, accidental death, etc.) or any complications in administering medications to the animal, unless due to the negligence of Dog Dot Cat LLC. Nor can Dog Dot Cat LLC be liable for injury, disappearance, death or fines of pet(s) with free access to the outdoors.
11. In the event of inclement weather or disaster, Dog Dot Cat LLC is entrusted to use best judgment in caring for pet(s) and home and will be held harmless for consequences related to such decisions.
