Report of Technological and Scientific Innovations

Discovered distinct material properties of BAV aorta With my research group, we demonstrated, for the first time, that aortic wall from bicuspid-associated aorta has distinct biomechanical properties compared to tricuspid (TAV) patients and that these properties do not suggest weaker aortic wall relative to TAV—contrary to clinical suppositions. We discovered that BAV aneurysmal aortic wall has greater tensile strength than that from diameter-matched TAV aneurysms. (See 64, 72 in Scholarship, research investigations.)

Pioneered characterization of ECM

microarchitecture

My research team pioneered the characterization of extracellular matrix (ECM) microarchitecture in human ascending aortic aneurysms using multiphoton microscopy (MPM) coupled with computational modeling to quantify ECM fiber anisotropy. The information gained from this approach will now be used in part to correlate in vivo-based imaging techniques with MPM-based interrogatories to adjudicate aortic wall disease state. Discovery of distinct regionspecific aortic biology and microarchitecture We demonstrated, for the first time, a differential pattern of ECM fiber orientation, alteration in oxidative stress pathways, gene expression and increased wall stress patterns in specific regions of the proximal ascending aorta, which helps explain the unique patterns of dilatation in BAV-associated ascending aortic aneurysms. (See 55, 63, 77, 95, 120 in Scholarship, research investigations.)

In vivo medial (aortic wall) hypoxia labeling

We demonstrated locally intense hypoxia specifically in aneurysmal regions of BAV ascending aorta and distinct from other types of degenerative aneurysms. Subsequently, I instituted a clinical trial testing the efficacy of regional pimonidazole-HCl-uptake (a novel probe for this indication) in aneurysmal aorta

and confirmed that uptake correlates with severity of disease and valve morphotype. The next phase is to develop an *in vivo* pimonidazole-based probe. (See 117, 161 in Scholarship, research investigations; and supported by a competitive renewal RO1 grant.)

Development of a patient-specific multi-parameter imaging-based aortic integrity scoring system for risk adjudication We created a patient-specific multiparameter imaging profile (from distensibility and morphometric data obtained by echocardiography, dynamic ECG-gated computed tomographic angiography (CTA), and wall shear stress data from 4D flow magnetic resonance imaging (MRI)) that is being correlated to local aortic wall material property differences, biomechanical testing, biological testing, and other microarchitectural assessments. These data are being computationally integrated in a stepwise manner to create a framework for a sophisticated constitutive model to predict aortic dissection. (See 89, 94, 169, 201 in Scholarship, research investigations; Emerel *et al.* in Scholarship, abstracts; and supported by a competitive renewal RO1 grant.)

Design and development of a dynamic perfusion-based 3D *in vitro* culture model

We designed and developed a patient-specific dynamic perfusion-based 3D *in vitro* culture model to mimic aortic media and study aortic smooth muscle (SMC) cell biology and extracellular matrix (ECM, *e.g.*, collagen and elastin) development, microarchitecture, and maturation using both polyurethane-based scaffolds and fibrin-based scaffolds. I have successfully demonstrated both collagen and elastin deposition in 3D constructs and have immortalized many distinct SMC lines from specific BAV phenotypes to allow for more controlled experimentation. Clinical Innovations:

Bicuspid valve repair operation

Designed a novel aortic valve repair operation for patients with severe aortic insufficiency and the most common morphotype (type 1) of bicuspid aortic valve (BAV), using fresh native pericardium to reconstruct the valve and convert it from a dysfunctional type 1 to a functional type 0 BAV. (See 75 in Scholarship, research investigations.)

Algorithmic approach for optimizing neurocerebral protection/outcomes in type A aortic dissection Designed and championed a protocol-driven, image- and neurophysiologic monitoring-based algorithmic approach to acute type A aortic dissection (TAAD) management aimed at optimizing neurocerebral outcomes that includes a novel technique of complete carotid arterial reconstruction. The developed strategy gave rise to one of the largest North American experiences with total aortic arch replacement for TAAD in the modern era. During my leadership tenure, UPMC became the largest patient contributor to the International Registry for Aortic Dissection over the course of the last 10 years with outstanding neurocerebral outcomes using the aforementioned approach. Concomitant thoracic aortic stent grafting and complete abdominal bare metal stenting The concept of more complete stenting and stabilization of the thoracoabdominal aorta at the time of acute type B aortic dissection has been evolving. Currently, there is only one FDA-approved device for this purpose, and I played a pivotal role as the largest enroller in completing the multi-institutional clinical trial that facilitated its approval. I have been at the forefront of developing the techniques

for acute type B aortic dissection	for this strategy and have the largest North American experience with its execution. (See 155, 203 in Scholarship, research investigations.)
Use of left subclavian to carotid transposition in context of acute type B aortic	Left subclavian to carotid arterial transposition is a previously described technique that is very rarely used by cardiovascular surgeons in favor of left subclavian bypass, particularly in the setting of emergent cases, <i>e.g.</i> acute aortic dissection, due to its technical difficulty. I have championed its use and demonstrated its safety and efficacy in the context of acute type B aortic dissection. I have the largest reported North American experience with its use in this context (See 37, 218 in Scholarship,
dissection	research investigations.)
