Privacy Policy

In order to facilitate your payment for our flag rental services we conveniently offer credit/debit card processing. Our shopping cart interacts with an established compliant third-party credit processing vendor via SSL links. They host and collect your billing information for the purpose of processing the payment for your flag rental display. We do not use your information for any other purpose. We do not store credit card and debit card numbers that are provided for this transaction.

When we collect billing information from you, we follow generally accepted industry standards to protect the information provided to us. We use an established third-party vendor via SSL links to manage processing of payments only.

Terms and Conditions

The Parties agree that the Seller, Flagkeepers, will provide a flag display of the customer's choosing.

Rental flag equipment and key information will be supplied by Flagkeepers. **Flagkeepers** is dependent on the customer to supply certain information regarding the requested custom designed flag display and the venue, date and time for the event.

The purchaser agrees that he/she shall be liable for any loss or damage to the rental equipment while on the premises of the engagement, resulting from accident, malicious mischief, fire or theft. Any damage or loss will be the financial responsibility of the purchaser. Reimbursement for that damage or loss will be payable to Flagkeepers.

Flagkeepers will provide an invoice to the purchaser that will detail the specific terms of the requested flag rental. This invoice will be signed by the owner of Flagkeepers, Richard Dinse. This invoice will also serve as the contract for the event. The purchaser is required to sign and date this invoice and return it to Flagkeepers either by fax at 760-732-3562 or email to Richard@flagkeepers.us. Attached is a sample of the Invoice/Contract form.

In order to reserve a specific date and time, Flagkeepers requires a **Non-Refundable Deposit of \$100.00**. This deposit is applied to the total event cost. Until we have received your deposit and confirmed your booking, we cannot guarantee our availability at a certain date and time. Your event date will be confirmed when the deposit is received.

All equipment provided by **Flagkeepers** for the event will be handled only by **Flagkeeper's personnel**. Our insurance prohibits others from loading, unloading, setting up or striking the flag display and other accessories associated with the display.

Payment Terms – Refund Policy

The remaining balance of the agreed upon rental charge is due in full on or before the date that the flag display is scheduled for delivery and set-up. The final payment is payable by cash, corporate check or credit card.

We understand that legitimate and unforeseen circumstances do occur and in those cases, we will gladly reschedule your event to the next available date that will work best for both of us. If you cancel or reschedule at least 14 days prior to your booked event date, you will not be liable for the remainder of the contract amount. If you reschedule your event, we will apply your deposit to your new booked event date. If you cancel less than 48 hours prior to your new booked date you will be liable for the full contracted amount. If we must cancel our commitment for any reason will not be liable for the remainder of the contract amount and we will refund your deposit in full.
