Your EOI will be reviewed and you will be advised whether your application will be accepted. Please allow up to six weeks and if urgent, you may email the circumstances to the Skilled Migration Officer.

Applications are assessed on a case by case basis, based on the information provided in your supporting documents and the Riverina region's skills and employment needs.

We occasionally put a hold on some nominated occupations until the need increases so please keep an eye on our web site for any updates.

Note:

For a number of these occupations further training, licensing and/or registration will be required with Australian industry specific organisations to enable applicants to work in Australia.
