IN NO EVENT SHALL BOW WOW BE LIABLE TO OWNER FOR MORE THAN THE AMOUNT PAID UNDER THIS AGREEMENT.
- 10. Right to Reschedule. Bow Wow reserves the right to cancel/reschedule appointments at its sole discretion, without penalty, at any time, with any new scheduled time to be agreed upon by the parties.
- 11. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois. Each party consent to the exclusive personal jurisdiction of the state and federal courts of the State of Illinois.
- 12. Force Majeure. Neither Owner nor Bow Wow shall be responsible for failure or delay in performing its duties under this Agreement if such failure or delay is due to tornados, thunderstorms, fire, floods, drought, riot, war or other acts of nature.
- 13. Travel Surcharge. If any Training Sessions are held at Owner's Address (listed below) are outside of the "Lakeview" (defined as Chicago City Ward 44) a Travel Surcharge, determined as either the cost of travel to Owner's Address or Ten dollars (\$10.00) whichever is greater, will be charged for each Training Session and subsequently invoiced. Additionally, in the event of adverse weather Bow Wow may charge a reasonable Travel Surcharge, as is necessary if the class is not rescheduled, subject to the terms set out herein. This Surcharge may be waived at Bow Wow's sole discretion.

- 7. City Walking Familiarization Package: A guided excursion in the area near your home meant to help your pup familiarize themselves with their new surroundings. Can also be useful for dogs that need socialization. Four 30 minute walks are included in this package.
